Disbursements are costs related to your matter that are payable to third parties, such as court fees. You must either pay any disbursements directly yourself, or place us in funds so we can make payment on your behalf when due.

These costs do NOT include the costs of defending you if the council or police bring a prosecution against you for breach of your personal and/or premises license. In such a situation we can act for you and our fees would be charged at £1,000 plus VAT plus the cost of counsel which is typically £750 plus VAT for a Directions Hearing and £1,500 plus VAT for the main appeal hearing although Counsel's fees are set by them and may vary according to the work involved in your case.
