HOME CONSTRUCTION PROGRAM: Habitat builds homes at reduced cost for families with limited incomes who are willing to contribute their own "sweat equity" in the building of homes for themselves and for others. Homes are sold with no-interest loans to families who show a desire to become homeowners by completing the Habitat partnership requirements. During our fiscal year ended June 30, 2022, one home was sold under this program.

DISCOUNTED BUILDING MATERIALS RESALE CENTER ("RESTORE"): Habitat's ReStore accepts donations from a wide variety of resources including individuals, companies, corporations, government entities and more. The donations can be building materials and related usable "stuff" that includes tools, appliances, and lawn and garden items. Examples include new, excess inventory, over-runs and used material and appliances. We sell these items creating income to be used in the construction of new homes in Wayne County for families in need of affordable housing. During our fiscal year ended June 30, 2022 sales from our ReStore program totaled \$397,178.
