Director Reports:

Treasurer's Report:

Larrie dispersed and discussed current budget. YTD, our net income is 15, 673. Some expenses are yet to come in, but club is doing well. Motion to approve report made by Renee, seconded by Dan. No discussion, motion carried.

Registrar's Report:

The current, official number of players registered is 212. One more U-10 girl would give the U-10 girls 9 players. Approximately 40 people opted to use post-dated checks. A motion to approve this report was made by Larrie, seconded by Nate. No discussion, motion carried.

Referee Assignor's Report:

Karen shared that a Neenah coach and manager will be suspended for behavior at our home tourney. CWSL has ability to advertise our tourney. Motion to approve made by Renee, seconded by Jason. No discussion, motion carried.

Communication Director's Report:

Renee is working on a power point for large, club communication meeting. Motion to approve report made by Marcia, seconded by Renee. No discussion. motion carried.

Player Development Director's Report: NA

Tournament Director's Report:

Our date is solidified. We can't advertise this until November 1. Karen will handle this advertisement. June 10-11 will be the weekend. A motion to approve this report made by Deb, seconded by Lisa. No discussion, motion carried.

Volunteer Director's Report:

Deb has sent out need for volunteers for closing date.

Director of Coaches Report:

There will be new coaches for different teams this year. Motion to approve report made by Dan, seconded by Jason. No discussion, motion carried.

Old Business:

Jason Wardour shared examples and pricing for prospective uniforms. Our club needs to choose our design soon so that other clubs do not take our choice. The uniforms will be on a three-year cycle. MCU has a dentistry clinic doing \$2500 a year for three years sponsorship. A discussion was held on sponsorship: Should we do one sponsor for boys and one for girls? Should one sponsor for away jersey and one for home? The members agreed on a striped uniform with black socks and black shorts. A motion was made by Dan to select the red/black vertical stripes, red/white vertical stripes, Joma, with black shorts and two pairs of black socks for our club. This was seconded by Nate. No discussion, motion carried. We will get size samples for the all-club communications meeting. No discussion, motion carried.

What about older kids that don't want to purchase new uniforms because they are only playing one more year. Members agreed that they could certainly use old uniforms unless all agree to buy. Sponsorship for uniforms will be researched by Larrie and Jason.

Team Forming:

There were five members on team forming committee. The teams will be as follows:

Boys:

U-10 Boys—15 registered. Still actively recruiting. U-10 is still open. We will need two teams. Kirk and Brad Tork will coach. Coaches will split evenly. U-11 Boys—12 registered. Coach Byom. U-12 Boys—13 registered. Aaron Dunn may coach. U-13 Boys—14 registered. No coach. U-14 Boys—16 registered. Rod Heck and Dan DeRoche will coach. U-15 Boys and U-16 Boys will play together—13 (U-15)+6 (U-16) will give a roster of 19 players. Dan Sullivan and Wilhorn will coach. U-18 have 20 boys. Kirk Willard will coach.

Lisa questioned if we could get these larger teams more tourneys? Discussion.

Girls:

U-10 Girls—8 registered, possibly three more girls interested. Scott Nyman will coach. U-11 Girls—16 registered. No coach. U-12 Girls—14 registered. Paul Vollert will coach. U-13 Girls—18 registered. Jennings and Wendels will coach. U-14 girls—21 registered. Jose Montoya will coach. A question was raised if we should we tell the four Point girls that there are 21 registered on their Kickers team? Should we offer another tourney? No, but we will figure out a way for those with so many players to allow as many as possible to play. U-15(16) and U-16(8)—24 registered. Five other girls from Stevens Point want to play U15/16. We will have to have a try-out. If the Point girls come, we would have an A and a B team. They would both play U-16. If the five don't all commit, we will need to cut two girls. The five Point girls would be on B team. We would keep them together. U-19 Girls—18 registered. Coached by Wendels. The club will refund money to a U-17 girl. October 24 will be try-outs for U-15/16. The committee will rank both top and bottom players. If five don't show up from Point, two Rapids girls will be cut. Jason and Derek will coach. Keith Wirtz may coach the B team. We need to give ten days' notice for try-outs. An email will be sent that try-outs will be 10/24, Washington field, 4:45. Five people will be on the try-out committee. The Point girls have until November 1 to decide if they will play.

A motion to accept the team forming suggestions presented by Jason and Dan was made by Renee. Seconded by Nate. No discussion, motion carried.

Fall fundraiser—Hidden Creek will do our fundraiser. Deb will be meeting with the coordinators soon. Frozen items will include pies, bread, and cookie dough. Looking at distributing between 12/5-12/9. One coordinator per team. A PDF and email sounds like the best option. Logistics need to be figured out. Will work backwards from distribution date. Form will be created. Orders need to be in by Thanksgiving. Deb will update us.

The club agreed to postpone the Jennings fundraiser.

Coaches will be assigned next week. Teams will be notified soon.

Karen needs tourney fees for WYSA meeting November 1. Larrie will figure out referees' fees to determine and will contact Karen before November and we will communicate via email.

Chris Yustus wants to direct fall soccer. No takers for tourney director(s).

We need Midstate reserved for practices.
