Meeting Called to Order at 6:05 pm

### 1. Coaching licenses

- a. Discussion had with Chris Lacey in regards to Coaching licenses last night
  - i. At this time, coaches will need to have licenses that follow our Bylaws as well as the WYSA policy. There will be no exceptions as this is an expectation especially at the higher levels of coaching.
  - ii. Any U15 State League team must list the Coach on the application, credentials will be checked, and if not appropriate, teams may not be approved with the district and the state
    1. *Lisa reported that in the past discouraged D license but at this time bylaws state we will reimburse the coaches*
    2. *Megan can email the state in regards to coaching cards at the games, as the current Roster and/or player cards do not list the license*
    3. *D Licenses will be only held in Milwaukee after this fall*

### 2. State League Teams

- a. PROPOSAL A: Is to have a U13 Coed State League Team and a U15 state league Team
  - i. Pros -
    1. Keep players solely within our club
    2. Families and kids that have been playing together can stay together as a team
  - ii. Cons
    1. Possibly not fielding the strongest teams in our area
    2. The possibility that the State will deny applications from one or multiple clubs within our area
- b. PROPOSAL B
  - i. Central Wisconsin District State League Teams
    1. PCYS, Marshfield, and Wisconsin Rapids have been in discussion in regards to Central Wisconsin State League Teams. MCU is agreeable to this plan although at this time will still try to field their own state league teams if able
      - a. Reasons for this

- b. Clubs in our district do not feel that they can field an entire team of state league level players at this time for a variety of reasons - this may change in the future

ii. Pros

- 1. These teams can be for any age group U12 and higher
- 2. The teams will not be designated as belonging to one club or the other, but it would be a Central Wisconsin Team
- 3. This will field the best team at each age group in our area and allow for the highest skilled players to play together, while allowing those not at that level to still play soccer within their club
  - a. As a reference, Many clubs outside of our area draw players from a 40 to 60 minute radius in order to provide the best opportunities for all soccer players within and outside of their clubs - but this is allowing for successful development and growth of the players. After speaking with Chris Lacey, his current club draws players from a 45 mile radius to form their state league teams

iii. How would this work?

- 1. Current plan is for 1 coach to be provided by PCYS and 1 coach to be provided by WR

iv. Current teams with tryouts at PCYS are at the U12, U13, and U15 levels

- 1. Tryouts would be had by PCYS and by WR
- 2. Anyone from any club can tryout
- 3. Each clubs group of evaluators would rank the players accordinging and select their top players (10 or less)
- 4. The top players at each tryout would receive a "CALL BACK", this is where the players are brought back together for an additional tryout
- 5. Practices would alternate between Point and WR as would Home Games

v. Cons

- 1. Determining how to register - what clubs do they go under
  - a. Discussion around alternating teams between clubs, pool rosters, etc. This would need to be worked out within the district and the state, but can be accomplished prior to the season start or a pool roster
  - b. Uniforms would need to be selected for the Central Wisconsin State Teams
  - c. It will be an adjustment for all to play with each other instead of against each other
  - d. Difficult for blackout dates, practices, other school schedules, etc due to multiple kids from multiple areas
