2. Referee checked in PCYS team via electronic cards. 3 guest players were provided.
3. \$125 to appeal to the State. Bren wants better clarification with referees and coaches.

- i. CWSL FC United Team 2006 Birth Year
  - i. 6/18/2021 Proposed motion of a Central Wisconsin FC 2006 State League Team
    1. This is the first team as a Central Wisconsin Team and continues to be a work in progress
      - a. Reasoning for creating this combined team?
        - i. Neither club had enough players to created a team within their own club that could compete at the state level
        - ii. Allow players that want a higher level of play, while allowing those that do not to player at a higher level or do more traveling to stay within their clubs
        - iii. Continues to allow for a CWSL league team
    2. Quick proposal due to timing of the need to make the state league team
      - a. Motioned by Megan ( Yes Vote), seconded by Brian, yes by Nate, Ron, Lisa, Chris for a total of 6 with a late response by Lynette due to vacation as a Yes = 7 (**Rule C:e of our Bylaws: Each position on the Board shall have one (1) vote, regardless of the number of people sharing the position. Five (5) voting members are considered a quorum.**)
      - b. No votes provided for Larrie, Amy, Karen, Randy, or Keith
        - i. Keith with comments June 20th 8:48 pm after tryouts were held
        - ii. Larrie proposed questions on July 9th
    3. Registration
      - a. They will be registered under the PCYS club for this season, but they are not a PCYS team - we need a club to house the team and this was decided for this season, but may change in future
    4. Who governs the Central FC Team
      - a. The CWSL League / District Committee will be involved in decisions in regards to this team
      - b. They will be under an independent set of Bylaws composed by the CWSL State Team Committee
    5. Fee structure - to be decided on by the committee
      - a. Current fees per player included field usage fees, league fees, referee fees, Presidents cup, 3 tournaments, uniforms, coaching fees
      - b. There is a current fee of \$100 per player to be divided evenly at this time within each club. This covers field usage and fees,
      - c. All fees are staying in a "Team Account " which is managed by PCYS. Funds which are not used by end of season are allocated back to the players
      - d. Total fees for all of the above is \$650
        - i. Our State League Fees only include the League/Reg/Registration fees, all tournaments are out our pocket as are uniforms for new players

6. Insurance and Liability
  - a. There are covered by WYSA
7. Uniforms
  - a. No sponsors this year, Logo to be designed, uniform will have Central Wisconsin FC
  - b. Cost for Uniform to be \$150
  - c. The uniform cycle for this team begins this year and will be every 3 years
8. Field Usage
  - a. WR Field Usage has been approved by RASI
9. Coaches
  - a. Scott Martin and Dylan Bassuener
10. Application to the State League
  - a. Just like all others, this team will apply, and that State Team Committee at WYSA will decide if they accept them or not
11. Volunteer Hours
  - a. Players will complete within the club the come from including tournament commitments
- j. Director of Coaching - Keith
  - i. Grassroots Coaching course in Wisconsin Rapids August 28th
  - ii. U12 Rhinelander Team
    1. Concerned as there were 6 U13 players on the roster, approved by the District - This is not a club decision but the district decision - see reasoning below
      - a. *Reasoning is there were no other teams in the club, therefore this was the only place for these girls to play*
      - b. *Initially only had 5 U13 and 7 U12 players, were able to add one more during the season*
    2. Asked to be discussed at CWSL Meeting
  - iii. PCYS Tournament concerns involving the U14 team
    1. Discussed that the local hosting tournament committee makes those decisions and the coach must be the one to lodge a protest
