 - Central WI Unified State league – This will start with U12 Co-Ed and Girls this fall. Both will have try-outs with multiple evaluators from multiple teams and players wanting to try out will pay a fee to cover the evaluator expenses. The recommendations would come back to the team committee to vote on if the team is qualified to participate in a state league. Each team has its own budget that comes from the player fees.

 - It was suggested that we look at tournament fees across the state for proposed fees for 2022-2023 season
 - U13 Girls team, can we allow a 4th tournament due to full roster
 - Only if over rostered, not if at roster size for age group
 - Note: after this meeting, the 2 U13 girls who were playing on U14 and U13C were approached about team assignments and decided to move to the U13 girls team. This meant the team was over rostered. A 4th tournament was then approved via email for this team
