 - WR Kickers Policies and Bylaws Manual
 - Updates in regards to volunteer hours
 - Addend policy to state: Managers fulfill their non-tournament for any child/team they are a manager. It does not fill all of their non-tournament hours if they have more than one child participating.
 - CWSL Meeting Updates
 - CoEd team counts: U9/10 rookie - 9 teams , U10- 6 teams, U11-6 teams, U12-6 teams, U13/14-6 (2-U13/4-U14), U15 - 2 teams U16-3 teams, U17-2 teams, U18-4 teams. U15 will also play the U14 teams but not U13.
 - Girls team counts: 10 - , U11 - 4 teams, U12 - 3 teams, U13/14 - 5 teams, U15-2 teams

 - Academy Registration - Registration will be capped at 50 players initially until we have a confirmed number of coaches.

 - Uniform sponsors - WoodTrust will again sponsor away uniforms. We are looking for a second sponsor.

 - Coach/Manager Meeting

 - Classic team tournament registration status - all teams are registered for summer tournaments
 - U15 Jahns team status - currently have only 11 girls. May need to combine or have a few U16 girls play with them. We will wait until school teams are formed and then see what options are available.

 - Academy Registration Open March 22nd
 - The fees will increase from \$60 to \$75 to help pay a stipend for the certified coaches.
