Review of last meeting minutes: [4-6-25 Kickers Board Meeting](#)

A motion was made to approve the minutes by Troi and seconded by Phil. The motion passed.

- President Updates:
  - Veo Usage
    - 2 cameras - 5 teams per camera - 1 with analytics, 1 without
    - \$3900/ year for subscription renewal
      - 85 games were recorded in the past year
      - Primarily used with the younger teams (U11-U14)
    - Will renew the subscription for another year
  - State League Tryouts
    - 2008 - 2010 - U18 team - June 9th at 5:30
      - A video meeting was held on 6/3/25. The U18 requested adding a second date, 6/16, as a second try out date and not just a rain date. Keith Wirtz and Shawn Mitchell were in attendance. After much discussion, the second date was allowed. Going forward, it was discussed that only one date should be set and that a second date would only be if the first date had to be cancelled, likely weather related.
    - U15 team - won't happen because it will be a split team (8th grade vs high school) - so no fall season for the high school players because of WIAA rules
    - U12/13 or 13/14 - will be June 3 and 8 (makeup) - 5:45 arrival with 6:00 start - should have at least 14 kids sign-up to have try outs
    - All evaluators should be adults. No high school students.
    - Must attend try out to be considered for the teams. No early offers. Players not at try outs cannot be added at a later date except in extenuating circumstances.

    - We will continue to look for ways to offset costs and increase fundraising.
    - A motion was made to approve the increased registration fees by Mike and seconded by Phil. The motion passed.
