National Estate Planning Awareness Month is held every October to highlight the importance of planning for the future. The goal is to encourage Americans to create or update their estate plans to protect their loved ones and ensure their wishes are carried out.

An estate plan is a set of legal documents that outlines how your property and affairs should be managed in the event of your death or incapacitation. Without one, a court will decide what happens to your assets, a process that can be both costly and stressful for your family.

### **Did You Know?**

- If you do not have an estate plan, the State of New Hampshire has one for you. If you die without a will, you are said to have died "intestate." New Hampshire Statute RSA 561-1 dictates how your property will be distributed if you die intestate, and it may not be what you intend or expect.
- Only 32% of Americans have a will, a 6% decline from 2023 and the first decrease in estate planning rates since 2020.
- Common estate planning documents are wills, trusts, powers of attorney, and healthcare directives. Do you have these in place?
- There are some famous Americans who died without a will, to name a few: Howard Hughes, Abraham Lincoln, James Dean, Ulysses S. Grant, and Martin Luther King Jr., to name a few!
- The "will of Uah" is the oldest known will in existence, and it was found in a tomb in Egypt. It dates to 2548 BC and leaves all property to his wife, Teta.
