Identity Theft Protection

Allstate Identity Protection delivers comprehensive fraud monitoring and powerful mobile and desktop cybersecurity to help you protect yourself, your family, and your finances from emerging threats. See and manage your personal data, safeguard your devices, and protect your identity. If fraud occurs, you will be reimbursed up to \$1 million for stolen funds and up to \$5 million for many out-of-pocket costs.†

If you leave Graham Packaging, this plan is portable at the same rates offered through payroll deduction. You must activate a direct bill relationship with Allstate Identity Protection by calling 800-789-2720.

Covered family member definition

Coverage can extend to you and family members “under your roof or wallet” plus senior family members aged 65+ who don’t live with you or who are not financially dependent up on you.

When is my coverage effective?

- **Annual enrollment**

Your coverage becomes effective on January 1st following the election of coverage. Coverage for your family, if elected, becomes effective on the same date as your coverage.

- **New hires**

If you elect coverage, that coverage becomes effective for you (or you and your family) on the date you are eligible for coverage.

- **Qualifying life events**

You can also elect or change coverage if you have a qualifying life event, such as getting married or having a child. Coverage due to a qualifying life event becomes effective the day of the qualifying event.

How to use the benefit

You’ll receive a welcome email between 24 and 48 hours after your effective date. You will also receive a welcome letter via regular mail. The welcome email contains your Member ID and a button to “Log In Now,” which links to the portal login page.
