

Rules & Regulations:

2026 “ATLANTIC CITY BALLET *Giveaway!*” Rules & Regulations

Guests must be 21 years of age or older to participate. ACB is not responsible for ineligibility due to computer error for promotional drawings. The Promotional Giveaway is subject to all applicable federal, state and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein.
