Through the power of God's word and the Holy Spirit, addictions and harmful sexual and violent behaviors are broken, incarcerated youth are ministered to, and relationships with God, others, and themselves are restored. Students are taught life skills, equipped to live with dignity, provided scholarship opportunities for a University Degree or Vocational Certification, then mobilized to serve their nation, and sustained and mentored through the local church.

HTC partners closely with Rendez-Vous Christ Church (RVC). RVC was started in 2016 to serve HTC graduates who were rejected by the local

HTC sets the Haitian operating budget and grants funds to DJH, which holds legal title to assets in Haiti on HTC's behalf. Funds released to DJH are recorded as HTC expenses; foreign-held assets appear only on DJH's balance sheet and are not reportable on this Form 990. Financial oversight is provided by the HTC Audit and Finance Committee, dual board treasurers, an in-country Director of Finance, and a U.S. Controller. HTC files this Form 990 following an annual external audit; DJH undergoes a separate annual CPA audit. Together, the two audits reconcile all ministry financials.

church because of their past. Today, they serve as church leaders, Sunday school teachers, welcomers, and small group leaders. Before the political instability, RVC served over 5,000 Haitians each week through services at four campuses. Through social media and broadcasts across Haiti, RVC's messages reach an additional 1,500,000 people.

Launched in September 2025, the Haiti Teen Challenge Prison Program provides spiritual, legal, psychological, and psychosocial support to individuals within Haiti's prison system. Through a holistic approach, the program seeks to address emotional, relational, and spiritual needs while helping participants rediscover hope and purpose. Through mentorship, discipleship, rehabilitation services, and the support of dedicated partners, men and women are finding renewed dignity and opportunities for lasting transformation. Early outcomes have already included baptisms, family reunification efforts, and steps toward successful reintegration.

In 2025, we granted over \$500,000 to DJH Fondation to purchase the Women's Center. This purchase will secure the women's program well into the future.

TRANSFORM: Through the power of the Holy Spirit During their time at HTC, students break the cycle of addiction and dependencies, all while reading and studying the word of God. They will confront their pasts and embrace God's new design of family. During their 18-month program, they are taught new life skills and serve in the community.
