Policies

UFDA Cancellation Policy: UFDA reserves the right to limit attendees as needed or to cancel the convention due to circumstances beyond its control. Should circumstances arise that result in the postponement of the convention, registrants will have the option to receive a full refund or transfer the registration fee to the same program at a future date. UFDA's liability for any cancellation is limited to a refund of the registration fee as outlined below and shall not extend to any other claims, including, but not limited to: travel expenses, cancellation fees, lost wages, inconvenience and other related costs.

Cancellations must be received in writing by email, or postmarked by April 29, 2026 to be eligible for a full refund. Cancellations made between April 30—May 5, 2026 will be refunded the registration fee minus a \$50 cancellation fee per registrant; additional events will not be refunded. Cancellations made on or after May 6, 2026 and no-shows will not receive a refund.
