

Freight and insurance requirements and responsibilities

- Artists are responsible for the secure transport of artworks to and from Araluen Arts Centre
- Artists are responsible for all transport insurance to and from Araluen Arts Centre

Transport and insurance of sold works will be the responsibility of the

purchaser

Transport of Artworks

- Araluen Art Centre and the Alice Springs Art Foundation will exercise all reasonable care in handling works submitted, but will not be responsible for loss or damage to any work whilst in the custody of the Araluen Art Centre
- Each artist is responsible at all times for maintaining their own insurance cover for damage to, loss of, or theft of the artwork, including insurance arrangements with the carrier
- The cost of freight and insurance of artworks are the responsibility of the artist. Artworks will not be accepted unless delivered and returned free of all freight and other charges

Delivery to Araluen Art Centre

- Each selected finalist will be responsible for organising, engaging and paying for a service provider to transport their artwork to Araluen Arts Centre for final judging
- Works that do not arrive by the nominated deadline will not be considered for finalist inclusion

- IMPORTANT: retain in a safe place all receipts and documentation from your delivering carrier
- IMPORTANT: Artists will need the following specifications when arranging return freight so please be sure to keep a record when despatching, as artworks will be returned in their original packing:

Dimensions of package as given to Carrier:

height (cm) x width (cm) x depth (cm)

weight (kg)

- Artists are responsible for the secure packing of artworks to Araluen Arts Centre for entry into The Alice Prize
- Artists are responsible for packing that can be securely reused for safe transport of entries on return or to purchaser
- Mark or label artworks with:

name of artist

title of artwork

preferred orientation

Include instructions for:

display / unpacking / repacking if required

send any specialised fixings packaged with the artwork (with instructions for use)

Include:

printed copy of the pdf copy of your exhibitor details emailed with your entry confirmation a return address for unsold artwork

Return from Araluen Art Centre

- Artists are responsible for organising and engaging a service provider for the return transport of unsold artworks from Araluen Arts Centre at completion of The Alice Prize

 Artworks collected in person or by freight carrier should be picked up and signed out from the Araluen Arts Centre 9-12 June 2026 between 10am - 4pm

- It is the responsibility of the artist to:
 ensure the delivery packing material is sufficient for the safe return of the artwork
 make own arrangements for return freight and book collection from the Araluen Arts Centre
 pay for return freight of unsold works
 - (For the purposes of arranging return freight for unsold artwork, a return freight Consignment Note/Number is preferred)
- Where arrangements have not been made for collection or return freight by 12 June 2026, the ASAF, after sending a notice to the artist of its intention to sell or otherwise dispose of the artwork, reserves the right to sell or otherwise dispose of the artwork after 30 days from 12 June 2026
- Purchasers will be responsible for organising and engaging with a service provider for the transport of their purchased artworks from Araluen Arts Centre at completion of The Alice Prize. The purchaser will liaise with Araluen Arts Centre for this process

Insurance

- Artists are responsible for all transport insurance for entries to and unsold works from Araluen Arts Centre
- Artists are strongly encouraged to insure their work against loss or damage in all stages of transport and handling
- Purchasers are responsible for all transport insurance of their purchased work from Araluen Arts Centre to a destination of their choosing
- Araluen Arts Centre is responsible for insurance of all works once received at: Araluen Arts Centre,
 61 Larapinta Drive, ALICE SPRINGS NT 0870 until such time as it is placed in the care of the
 nominated carrier or person nominated by either purchaser or finalist to collect

Release and Indemnity

- The artist releases to the full extent of the law, the Alice Springs Art Foundation, the Northern
 Territory of Australia and its officers, employees, agents, subcontractors, visitors and invitees from
 all responsibility or liability for the loss of or damage to any property and the injury to or death of
 any person in connection with this Conditions of Entry
- The artist agrees to indemnify and keep indemnified the Alice Springs Art Foundation and the Northern Territory of Australia against any losses, damages, costs, expenses or other liability suffered or incurred by the Alice Springs Art Foundation or the Northern Territory or incurred in dealing with any claim against the Alice Springs Art Foundation or the Northern Territory in connection with this Conditions of Entry, save to the extent the liability directly arose as a result of the Alice Springs Art Foundation or the Northern Territory's negligence
