Parking Ban Ordinance

- A. A parking ban will be in effect November 1st – April 15th, between 10:00pm and 7:00am. The parking of vehicles is prohibited on all roads within the Town.
- B. Snow Removal Emergency: The Highway Superintendent is authorized to declare a snow removal emergency when in his/her judgement, snow is likely to accumulate, or has accumulated, at such depths as will make snow removal difficult if vehicles are left parked on the town streets. Notice of such emergency shall be conveyed to the public via media announcement and will remain in effect until such time the snow emergency is declared ended via media announcement. No vehicles may park on any road within the Town during any such Snow Removal Emergency.
- C. Violators of this ordinance that prevent plowing of a roads may be towed and the vehicle's owner will be responsible for all towing and storage charges incurred by the town. The Town is not responsible for damage caused by town equipment to a vehicle that is in the town's right-of-way.
