Annual Season Pass structure and daily fee rates

April 2021-October 2025

I personally developed and implemented the annual season golf pass and daily fee rate schedule for board approval. This format has been modified and continues to be used for enrollment each year to ensure customer retention and growth.

See attached document for the upcoming 2026-2027 enrollment.

Budget operations- April 2021- August 2026

Prior to being chosen for the position of GM/ Director of Golf I was asked to create and submit a complete detailed budget for the entire golf operations. This was submitted and was accepted as the operating budget by the board in April 2021. Each year the budget is modified to meet market conditions and operational demands. The annual operating income statements for each year reflect the effectiveness of my abilities to project and generate revenues, oversee expenditures and deliver a successful result.

Tournament/event promotion – April 2021- August 2026

The facility hosts several scheduled events each season. Planning the season long course tournaments, league schedules and various outings has attributed to the success of the facility.

I work hand in hand with all of these events to ensure that they are properly scheduled, appropriate fees are charged and mostly to deliver the satisfaction of the specific organizations our met.

Community fund raising events such as the Massena Hospital Foundation, Massena Central High School Hockey and Golf Team, Darrell Lazore Memorial Foundation, Mohawk Casino Employee Memorial event and the Agati Scholarship Foundation continue to host their events each year with The River Course.

I have been instrumental in planning, promoting and executing several events directly for the Town of Louisville over the past 6 seasons. Working directly with the town board chairperson and town staff. The Hometown days golf tournaments and this year the 100 years of golf on the St. Lawrence.

The River Course season events schedule is filled with weekly leagues. I work daily and weekly with The Elks league, Monday night ladies league, Tuesday Men's Twilight, and Friday Mixed Team Scrambles. These leagues have been strong supporters of the facility. Working with the Waddington league chairperson 2 years ago we brought their league here with an annual revenue source of 18K plus.

The annual course improvement event generates approximately \$7,500 in revenue that is used to prepare the course for the winter and provide materials for maintenance throughout the upcoming year.

Continuance of these programs is essential to the growth and sustainability of the facility.

I will continue to use social media platform Facebook and direct email communications.

The Fore-Up company we are using to support our online tee time booking has a marketing plan that I will look into for the upcoming 2027 season. These usually come with either a trade out for tee times weekly or a hard cost to the facility to use their resources.

This person will assist me to promote and execute a summer long program for golfers of all skill levels to be introduced to the game.
