Our Vendor Application & Selection Process

- Vendor participation is a two-part process: Vendor Qualification and Vendor Selection.
- All Vendor Applications (online or paper) must be received by MRACG by October 22, 2025, to be considered for participation. All applications must be submitted with a \$10 non-refundable administrative review fee.
- Our shows are juried and all vendor applications must meet the requirements of our Standards Committee to be considered as Qualified Vendors:
- Vendors who have been vendors in MRACG Shows within the last 12 months do not require Jury approval IF they are not selling any other products that have not been previously approved.
- All applications - including those that do not require Jury approval - will be considered after the October 22, 2025 application deadline.
- Vendors will not be notified prior to the October 22, 2025 deadline. Qualified Vendors who are selected to participate will be notified via email by October 29, 2025. This email will include information about payment of your booth fee.
- *To secure your space, payment in full for your booth must be made within 10 days of the notification date. If payment is not received you will be moved to the wait list. We are unable to provide refunds for vendors that cancel.*
