Our general credit policy is that the entire funeral amount is due and payable prior to services being rendered. We accept cash, check, Visa, MasterCard, Discover and American Express. For your convenience we also accept the use of debit cards. Credit (2.5 % Processing Fee) or debit cards cannot be accepted as payment for pre-need services.

Acceptable credit arrangements include: assignable life insurance policies(4% Fee), entitled benefits from Veterans Administration and state or citywelfare payments as well as One Main Financial, a lending institution.

*A late fee of 1.5% (18% per year) will be assessed on any unpaid balances. These charges are incurred from the day services are selected. All credit accounts require that **all cash advance items and merchandise to be paid prior to services being rendered.***

As stated in the contract, should a default on payment occur, all reasonable attorney fees and court costs will be the responsibility of the person who is legally allowed to arrange the services and has signed the contract.

We regret that we are unable to accept settlement of estates through attorneys or probate courts as a means of financial arrangements. Any responsible parties are encouraged to apply for reimbursement from the estate. Once an estate has been established.

The good and services shown below are those we can provide to our customers. You may choose only those items you desire. **However, any funeral arrangement you select will include a charge for our basic services and overhead. If legal or other requirements mean that you must purchase any items you did not specifically ask for, we will explain in writing on the statement we provide describing the funeral goods and services you selected.**

1. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$ 2990

Our fee for the basic services of the funeral director and staff include, but is not limited to, a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing of necessary permits, consultation with the clergy, cemetery, crematory, common carrier, assistance with insurance papers, planning the funeral or memorial service and supervision of each service requested or required. This fee for our **basic services and overhead** will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials and forwarding or receiving remains.)

2. EMBALMING \$ 875

Embalming is a chemical process which provides temporary preservation of the body and eliminates health hazards. A person licensed by this state must complete this procedure. **Except in certain special cases**, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

MERCHANDISE

We offer different styles and prices of caskets, and an alternative container from which to select. Since many caskets appear similar, they may differ greatly in quality and construction, we offer the following in order to assist you in making an informed decision.

PROTECTIVE These caskets are designed by the manufacturer to resist the entrance of air, water and other outside elements. They may be constructed of varying gauges of steel, copper or bronze.

NON-PROTECTIVE These caskets are **NOT** designed by the manufacturer to resist the entrance of air, water and other outside elements. They may be constructed of metal, hardwood, cardboard, or wood products covered with fabric.

A complete list of the caskets and outer burial containers offered will be provided to you.

Casket selections range in price from - **\$ 1,195 to \$ 3,400**

Outer burial containers range in price from - **\$ 1,695 to \$ 16,000**

In most areas of the country, state or local law does not require the purchase of an outer burial container; however in certain cemeteries they are required.

This charge also includes all coordination and notification to necessary church, clergy, cemetery, and military honors organizations as well as staffing present and any additional equipment that can be provided by the funeral home at scheduled graveside service. **This charge does not include an urn, urn vault, cemetery fees, church/clergy fees, obtaining certified copies of death certificate, or obituary fees. Mailing of cremated remains is a separate charge and will be added accordingly.**

If you want to arrange a **direct cremation**, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide, which is required by state law, has a wooden base and a cardboard top.

Your funeral director can explain the many options available with immediate burial or cremation. Please feel free to ask any questions you may have.

***State and local laws do not require the purchase of a casket for cremation; however they are available to you. These caskets range in price from – \$ 1,395 to \$2,895**
