1. Introduction

- Compliance with a legal obligation.
- Our legitimate business interests.

4. Data Sharing and Disclosure

We may share your information with:

- Service providers who support our operations (e.g. IT, hosting, email services).

- Regulatory authorities or law enforcement, where required by law.

We require all third parties to respect the security of your data and treat it in accordance with the law. We do not sell or rent personal data to third parties.
