Remarks

*Rifle Range Road Culvert Project had \$200,000 CRAF and \$400,000 of FY 2022 funds dedicated but bids came if higher than expected and an additional \$400,000 of FAEF was needed to complete the project. The project started in FY 2022 and was completed in early FY 2023. Total project cost is \$1,000,000.

Due to cost overruns on other projects this project will be completed utilizing ARP funds.

Striping items are not complete on all roads. Waiting on striping contractor. Estimate \$7,335 remaining in raised pavement markers.
