## **RESOLUTION OF THE ELMORE COUNTY COMMISSION TO CONTINUE TEMPORARY RELOCATION OF POLLING PLACE FOR PRECINCT NO. 0231**

**WHEREAS**, the polling place for Precinct No. 0231 was previously changed from the Millbrook Civic Center (3560 Grandview Road, Millbrook, Alabama 36054) to the Millbrook Memorial Center (3170 Park Circle, Millbrook, Alabama 36054) for the May 19, 2026 Primary Election due to an emergency necessity arising from a scheduling conflict caused by a change in the election date; and

**WHEREAS**, said temporary relocation has already been implemented and publicly noticed to the voters of Precinct No. 0231; and

**WHEREAS**, reverting the polling place back to the Millbrook Civic Center for the Primary Runoff Election would require additional public notice, create potential voter confusion, and impose unnecessary administrative costs upon the County; and

**WHEREAS**, the Millbrook Memorial Center has been inspected and determined to be a suitable polling location and remains available for continued use; and

**WHEREAS**, maintaining the current polling location for the Primary Runoff Election will promote continuity for voters, reduce confusion, and result in a more efficient and economical administration of the election;

**NOW, THEREFORE, BE IT RESOLVED** that the polling place for Precinct No. 0231 shall remain at the Millbrook Memorial Center, located at 3170 Park Circle, Millbrook, Alabama 36054, for the Primary Runoff Election to be held on June 16, 2026.

**BE IT FURTHER RESOLVED** that this continuation of the previously approved temporary polling location is necessary to ensure consistency in voter information, avoid duplicative notice requirements, and promote the efficient use of County resources.
