WHEREAS, currently Precinct No. 0231 polling place is located at Millbrook Civic Center (3560 Grandview Road, Millbrook, Alabama 36054); and

WHEREAS, a request was brought forth from Elmore County Probate Judge and his staff to temporarily change this polling place due to an election date change and previously scheduled event; and

WHEREAS, voting places in the State of Alabama may not be changed within three months before an election is to be held absent an emergency that necessitates a change in voting place; and

WHEREAS, the date of the May Primary Election was changed by the Secretary of State after the calendar had been set; and

WHEREAS, the Millbrook Memorial Center located at 3170 Park Circle, Millbrook, AL 36054 is available to be used for a temporary polling location; and

WHEREAS, following an inspection of the Memorial Center by Probate Judge Jason Britt, Elections Specialist Vicki Stewart, and Elmore County leadership.

NOW, THEREFORE, BE IT RESOLVED that the polling place for Precinct No. 0231 be temporarily changed for the Primary Election to be held on May 19, 2026 from Millbrook Civic Center, located at 3560 Grandview Road, Millbrook, Alabama 36054 to Millbrook Memorial Center located at 3170 Park Circle, Millbrook, Alabama 36054. This change is only in effect for the May Primary Election on May 19, 2026.
