Due to the large scope of STEER, Inc.'s ministry with farmers/ranchers located throughout the country, I agree to the following conditions: (1) The livestock purchased for STEER will be ear tagged and/or branded with the STEER brand. The livestock will not be branded with my own brand as they are the property of STEER. (2) I will market my project/projects for missions in the name of STEER, Inc. (If I am selling some of my own livestock or crop at the same time, I will simply take the overall average and have the marketing agent make the check payable to STEER, Inc.) (3) Whenever an animal dies or STEER's crop is destroyed by storm, if I contact STEER, Inc. immediately, they will cover the loss on the investment through their Insurance & Depreciation Fund. (4) I will not sell any Cow UNITS unless I have contacted the STEER office first. If I have any questions regarding any of these four conditions. I will call your office.

## THE INTERNAL REVENUE REGULATIONS GOVERNING DONATIONS OTHER THAN OUT OF POCKET MONEY

While STEER, Inc. is recognized by the Federal Government as a tax exempt, non-profit organization and is, therefore, qualified to issue tax-deductible receipts for donations, we feel we should inform farmers and ranchers of rules regarding deductions from income taxes for such donations as feed, grazing, labor, etc., which is normally reflected in the gain that is put on an animal while in his care and for which STEER, Inc. issues receipts. You may deduct the expenses that go into your mission project and paid out labor. You may not deduct your own labor.

For your convenience, we quote a portion of the rules that may apply in helping you determine what portion of our receipt to you can be legally claimed as deductible.

"IF A CONTRIBUTION IS MADE IN PROPERTY OTHER THAN MONEY, THE AMOUNT OF THE DEDUCTION IS DETERMINED BY THE FAIR MARKET VALUE OF THE PROPERTY AT THE TIME OF THE CONTRIBUTION."

Please be informed that when you receive a "Notice Of Sale Form" from STEER, Inc., that this is not a tax-deductible receipt but only gives information on the gain from your project.

If STEER, Inc. purchases livestock from me personally or I act as an agent on behalf of STEER, Inc. during the purchase of livestock, I hereby covenant that I am, or the seller is, the lawful owner of said cattle, that they are free from all incumbrance, that I (they) have good right to sell the same.

This Agreement Form should be returned to STEER, Inc., giving pertinent information on reverse side when project is begun for missionary stewardship, with bill of sale. STEER, Inc. will then send check to cover purchase cost and expenses.

The livestock and crop described on reverse side represents a trust from God. It is purchased with dedicated funds; it will increase in value and every dollar added will go to the Lord's worthy cause in winning lost men and women to Jesus Christ. This includes the percentage required for insurance, depreciation and operational expense taken by STEER, Inc. since STEER, Inc. is in itself a missionary testimony and the percentage taken is a donation towards missions through this testimony. STEER, Inc.'s financial statement is available upon request.

It is hereby understood: (1) in the event of death of animal or crop loss, STEER, Inc. will cover the original price paid for the animal or crop through its own Insurance & Depreciation Fund. The farmer should report loss in writing to STEER, Inc. as soon as possible, sending receipt of loss. (2) STEER, Inc. will pay any and all veterinarian services upon receipt of proper billing. (3) Should you feel it necessary to sell animal(s) before ready for market, please contact us for instructions. (4) When animal(s) or crop are marketed, have your marketing agent make check payable to STEER, Inc. (5) You will receive from STEER, Inc. a receipt for the amount reflected as gain during the time animal or crop was in your care. The missionary society is notified of your donation and receives a check from STEER, Inc.

## Liability

The farmer, as well as his or her family, employees, agents, servants and subcontractors, agree to indemnify and hold harmless STEER, Inc. from any and all liability arising as the result of his or her participation in the livestock program or in the "God's Acres" program and any related programs implemented in the future.
