Children Served

First Light Child Advocacy Center provides coordinated, trauma-informed services to children impacted by abuse, violence, or traumatic experiences. Support is centered on safety, reducing further harm, and helping each child begin the healing process.

MDT Reviews

Multi-Disciplinary Team (MDT) reviews ensure a coordinated response to cases involving child abuse or trauma. These meetings bring together professionals from law enforcement, child protective services, healthcare, mental health, and the legal system to review cases, share information, and determine next steps to support children and families.

Interviews**

Forensic interviews provide children with a safe, child-friendly space to share their experiences in a developmentally appropriate way. These interviews support investigative and legal processes when abuse or trauma is suspected.

**Medical
Services**

Medical services support the physical wellbeing of children when concerns of abuse or trauma are present. These services may include medical evaluations, hair testing or referrals to ensure a child's health and safety needs are addressed.

Referrals**

Mental health referrals connect children to specialized, trauma-informed care. These services help children process their experiences, build coping skills, and continue healing in a supportive environment.

Advocacy services support children and non-offending caregivers as they navigate the systems involved in addressing abuse or trauma. Advocates provide guidance, resources, court accompaniment, and ongoing support throughout the process.

Through forensic interviewing and MDT coordination, children are supported in telling their story once, limiting re-traumatization and preserving the integrity of investigations.

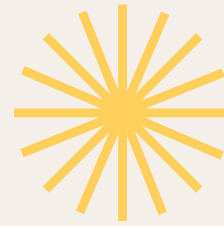


Services We Offer

- Professional training and community outreach

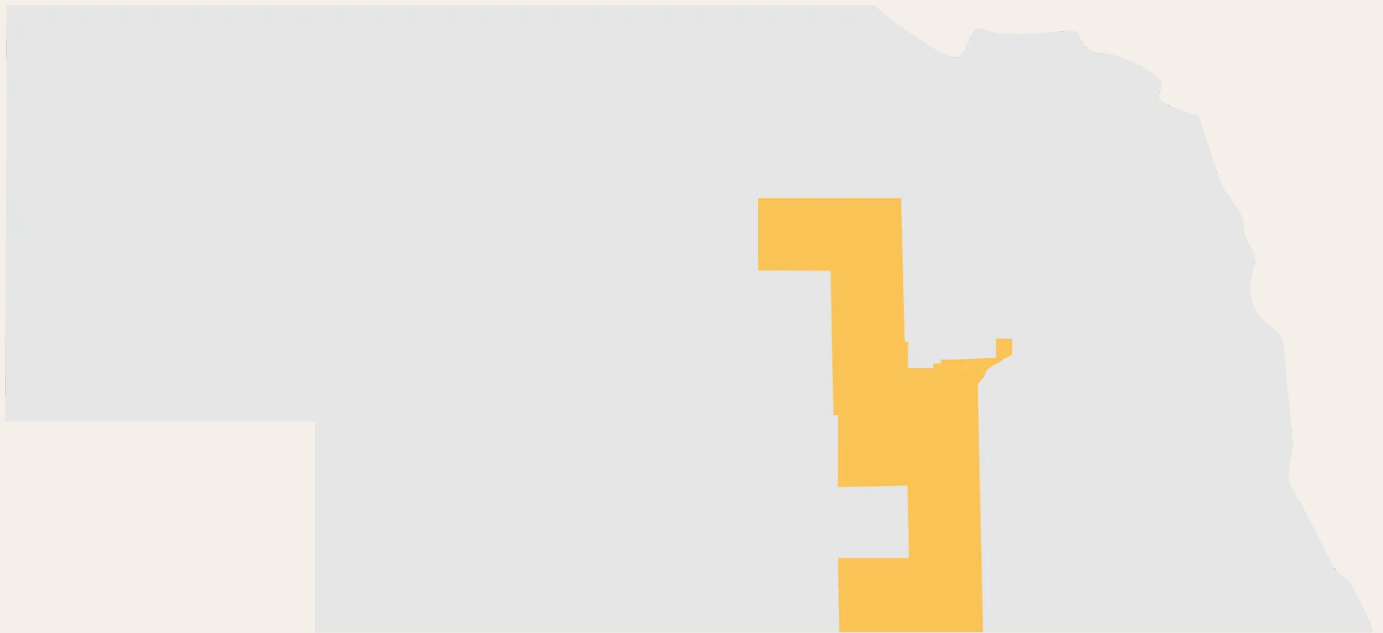
