

# Stablebase™ Spray Foam

## LIMITED LIFETIME WARRANTY

Firestable Insulation Company (hereinafter “Firestable”) warrants Stablebase™ Spray Foam (hereinafter the “Product”) when installed by Firestable authorized contractors using Firestable trained applicators and Firestable authorized equipment and applied in accordance with the product specification and guidelines, will perform as stated in the Technical Data Sheet (hereinafter the “Limited Lifetime Warranty”). This Limited Lifetime Warranty is in effect throughout the ownership of the building by the original owner provided the original purchaser registers with the Warranty Department of Firestable within 90 days from the date of the installation of the Product. Firestable’s sole responsibility under this Limited Lifetime Warranty shall be to replace any defective Product at the cost of the material only. Firestable shall not be responsible for labor cost, or any other costs whatsoever related to, or in connection with, the removal or installation of either the original or replacement Product.

Firestable shall not be held liable under this Limited Lifetime Warranty for defects or failure caused by improper installation of the Product (which is not in strict adherence with Firestable’s written instructions) or damage due to storms, fire, floods, hurricanes, acts of God, abuse, neglect, or defects, failure or damage caused by materials adjacent to the Product, or damage caused by any repairs or alterations after completion of the original installation of the Product.

Statements made by contractors and installers about the performance qualities of the Product or contained in advertising literature do not constitute an expressed warranty. This Limited Lifetime Warranty gives the building owner specific legal rights, and the building owner may also have other rights, which can vary from state to state. Building owners making claims under this Limited Lifetime Warranty must notify Firestable in writing of the defect promptly following its discovery and must submit with this notice proof of the date of purchase, contractor who applied the Product and the date, location and description of the circumstances under which the defect occurred or was first noticed. Notice shall be given in writing to the address below.

FIRESTABLE DISCLAIMS ALL OTHER EXPRESS OR IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. UNDER NO CIRCUMSTANCES WILL FIRESTABLE BE LIABLE FOR SPECIAL, INCIDENTAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES, ARISING FROM OR IN CONNECTION WITH THE PRODUCT OR ITS USE. FIRESTABLE SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM BREACH OF THE EXPRESS WARRANTY OR FOR THE COST OF REMOVING, INSTALLING, OR REINSTATING ANY REPAIR OR REPLACEMENT.
