



## All Things New Plan Template

Each ACC is expected to create a plan or two to submit to the Planning Office by December 31, 2025. Each of these plans will be reviewed and will be brought to the bishop for approval.

**Area Catholic Community Name:** Parishes on the Prairie

**Date:** December 1<sup>st</sup>, 2025

### **Goal 1: Close two parishes (PREFERRED)**

**Specific:** Close Our Lady of the Angels (Sauk Centre) and St. Donatus (Brooten)

#### **Achievable:**

- Currently there is not a weekend Mass at St. Donatus and parishioners are attending Mass in other parishes in our ACC.
- By closing two parishes fuller liturgies being celebrated across the ACC as desired by the Bishop.
- All parishioners would have access to a Sunday Mass within a 20-minute drive.

#### **Relevant:**

- In Sauk Centre, two Catholic churches less than six blocks away may not be the best use of finances.
- This will allow for continued healthy liturgies and foster closer faith communities, be better stewards of finances and allow for increased pastoral ministry.
- It will lessen travel and work load of the priests.

#### **Action steps**

##### **Jan 4<sup>th</sup>, 2027**

- As of Jan 4th, 2027, the new weekend Mass Schedule would be Saturday, St. Paul's 4pm, St. Peter and Paul, 5pm. Sunday, St. Paul's 8am, St. Alexius 8am, St. Paul's 10am, St. Francis de Sales 10am. (These Mass times are an ongoing conversation).

##### **Jan 4<sup>th</sup>, 2027**

- All Masses will cease at St. Donatus and Our Lady of the Angels.
- List the St. Donatus and Our Lady of the Angels properties (rectories, churches, lots) for sale. Selling is the first option. The committee will gauge interests in the properties and look to demolish buildings if not sold in a timely manner to be good stewards of finances.

## **Governance and Finance**

### **Effective July 1<sup>st</sup>, 2026**

- In both plans the number of corporations would reduce from six to one.
- The new finance council would consist of six members. This council would consist of a parishioner from each current parish to be pastorally considerate.
- Two trustees would be chosen by the pastor.
- We will adjust insurance coverage to all our structures to a 50% variable replacement cost. Then, allocate 75% of the resulting savings into an investment account to help us become more self-insured over time.
- One main parish office in Sauk Centre.
- One satellite office in Belgrade is allowed to be open Wednesdays and Fridays from 9am-3pm to serve the needs of parishioners in southern part of the ACC.
- Holy Family School's subsidy will not exceed 40%
