This price list does not include cash advance items such as but not limited to, death certificates, obituaries and permits. If any, these will be itemized on your statement of goods and services.

Professional Services

I. BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF	\$400
Our services include: Arrangement conference, planning and coordination of services, clerical and administrative services, preparing and filing necessary permits or notices, and a proportionate share of overhead costs. (This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

VI. DIRECT CREMATION

\$1,090 to \$1,785

Our charge for a Direct Cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; crematory fee; transportation to crematory; obtaining necessary authorizations; and the cremation permits from County Health Department and Medical Examiner.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed of corrugated cardboard/wood composite.

* It is the policy of Cremation by Grandview, Inc. to refrigerate the body of the deceased should it be remaining in our care for more than ninety six (96) hours. Special circumstances may require refrigeration immediately. There is no additional charge for refrigeration for the first ninety six (96) hours. Additional refrigeration will be charged at a rate of \$150 per day.
