CANVASSING RETURNS AND DECLARING RESULTS OF THE MAY 2, 2026 ELECTION OF THREE PERSONS TO THE BOARD OF EMERGENCY SERVICES COMMISSIONERS, AS PROVIDED UNDER HEALTH & SAFETY CODE, SUB-CHAPTER C, SECTION 775.0345.

Commissioner Redus introduced an Order and made a Motion that the same be adopted. Commissioner Jones seconded the Motion for adoption of the Order. The Motion, carrying with it the adoption of the Order, prevailed by the following vote:

Commissioner Jones thereupon announced that the Motion had duly and lawfully carried and that the Order had been duly and lawfully adopted.

The Order thus adopted reads as follows:

ORDER CANVASSING RETURNS AND DECLARING RESULTS OF THE MAY 2, 2026 ELECTION OF THREE PERSONS TO THE BOARD OF EMERGENCY SERVICES COMMISSIONERS, AS PROVIDED UNDER HEALTH AND SAFETY CODE, SUB-CHAPTER C, SECTION 775.0345.

WHEREAS, Notice of this Meeting of the Board of Emergency Services Commissioners, has been given in the manner and for the time required by law; and

WHEREAS, at an election held on the 2nd day of May, 2026, in the District there was submitted to the qualified voters an election ballot for the election of three persons to the Board of Emergency Services Commissioners, as provided under Health & Safety Code, Sub-chapter C, Section 775.0345; and

WHEREAS, at the election, the votes were cast in favor of the following declared candidates, as follows:

CHRISTY SANDERS GRAVES:	53 votes
SHANNON LENOX:	56 votes
STEVEN JONES:	77 votes
SHAREEN REDUS:	74 votes
WYATT WATKINS:	49 votes

WHEREAS, the following three persons received, respectively, the most, the second, and the third most votes cast at the election as provided by law, to wit,

STEVEN JONES:	77 votes
SHAREEN REDUS:	74 votes
SHANNON LENOX:	56 votes

THEREFORE, BE IT ORDERED, ADJUGED AND DECREED BY THE BOARD OF EMERGENCY SERVICES COMMISSIONERS OF HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 4, as follows:

Section 1: The matters and facts recited in the preamble of this Order are found and determined to be true and correct; that all acts, conditions and things required to be done precedent to declaring the official election results for the election of three persons to the Board of Emergency Services Commissioners and tallying the votes cast have been properly done and performed and have happened in regular and due time, form and manner as required by law.

Section 2: The following three persons received, respectively, the most, the second most, and third most votes cast at the election as provided by law:

- STEVEN JONES:** 77 votes
- SHAREEN REDUS:** 74 votes
- SHANNON LENOX:** 56 votes

as provided under Health & Safety Code, Sub-chapter C, Section 775.0395, and said three persons are declared to be elected to the post of Emergency Services Commissioner of HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 4, with the four-year terms of office commencing June 1, 2026
