These prices are effective as of January 9, 2026, but thereafter subject to change without notice.

The goods and services shown below are those we can provide for our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean that you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to purchase for you such as cemetery or crematorium charges, flowers and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

Terms of Payment

1. Plan for payment in full must be made at the time of arrangements.
 2. Cash, Check, Credit Cards and Assignment of verified insurance policy are all acceptable forms of payment.
 3. A 3.5% convenience fee will be applied to all items that are paid via credit card.
 4. A \$500.00 estate filing fee will be applied to the total contract amount, assets must exceed the value of services for approval.

A-1. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$2950.00

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service, arrangement conference with family or responsible party; arrangement of services/disposition; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to and following the funeral including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in this charge is overhead expense relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for direct cremations, immediate burials, and forwarding or receiving remains.)

2. EMBALMING.....\$705.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

This charge does not include the services of staff or the use of facilities for any visitation and/or rites or ceremonies prior to forwarding of the body. The cost of other than local transportation in vehicles of the funeral home is \$3.00 loaded mile.
