The Boys & Girls Club of Moody County raffle giveaway of an Old Hickory Brand Lofted 10' x 20' Shed **or** \$3,500 Old Hickory Shed credit **or** \$3,000 cash prize begins on Monday, May 23, 2022 and ends on Wednesday, June 29, 2022. By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Boys & Girls Club of the Northern Plains (BGCNP) and Boys & Girls Club of Moody County, which shall be final and binding in all respects. BGCNP is responsible for the overall administration of the Contest. BGCNP reserves the right to alter or change Contest rules at any time.

TERMS

A. ELIGIBILITY: Open to all individuals who are 18 years of age or older as of June 29, 2022. The Boys & Girls Club of Moody County or any businesses handling ticket sales are not responsible for late, lost, damaged, incomplete, misdirected, illegible or mutilated entries. Winner must show proof of an identity with a photo ID in order to claim the prize. The raffle drawing will take place June 29, 2022 at an event hosted at Boys & Girls Club of Moody County at 5:30 p.m. (Winner does not have to be present to win). BGCNP reserves the right to revoke any prize or remove an entry if the entrant does not meet any or all of the eligibility requirements, or if the entry or winning ticket has been damaged or altered. Raffle design is under the management of BGCNP. If you are the winner of the Shed Grand Prize, redemption of your prize will be held at Ramsdell's Brookings after the raffle drawing event. Winning ticket holder has the option to a \$3,500 credit towards a different Old Hickory Brand Shed purchase or \$3,000 cash prize in place of the Old Hickory Brand Lofted 10' x 16' Shed. Winners are responsible for filling out any paper work at the site of the distributer (Ramsdell's Brookings, SD). All federal, state, local and other taxes are the sole responsibility of the applicable winner.

B. HOW TO ENTER: Enter the Contest at the Boys & Girls Club of Moody County, First National Bank, The Spot, Maynards, or River's Edge Cooperative in Flandreau during the Contest Entry Period, or at greatfuturessd.org. Each person who registers for the Contest earns one (1) chance per raffle ticket to win the shed or one (1) chance per raffle ticket to win the \$3,500 shed credit or \$3,000 cash. Purchasing multiple tickets will improve your chance of winning the prize.

C. THE PRIZE: BGCNP will award one (1) grand prize to one (1) Contest entrant. The winner of the raffle drawing will win the Old Hickory Brand Lofted 10' x 16' Shed **or** \$3,500 Old Hickory Shed credit **or** \$3,000 cash prize. BGCNP reserves the right in its sole and absolute discretion to award a substitute Prize of equal or greater value if the Prizes described in these Official Rules are unavailable or cannot be awarded, in whole or in part, for any reason. If the actual value of the Prizes turns out to be less than the stated value, the difference will not be awarded in cash; the difference will go back to the Boys & Girls Club of Moody County. Restrictions, conditions, and limitations may apply. BGCNP will not replace any

lost or stolen prize items. All federal, state, local and other taxes are the sole responsibility of the applicable winner.

D. WINNER SELECTION: The winner will be selected in a random drawing from among all eligible entries received throughout the Contest Entry Period. The random drawing for the Contest will be conducted on Wednesday, June 29, 2022. The random drawing will be conducted by BGCNP or its designated representatives; all decisions are final. Odds of winning will depend on the number of eligible entries received not more than 1:500. One ticket will be drawn for the Old Hickory Brand Lofted 10' x 16' Shed. Winners will be notified by phone or email within two (2) business days of the random drawing. BGCNP is not responsible, and may disqualify an entrant, if the entrant's phone or email does not work or is changed. Any winner notification not responded to within 30 days or returned as undeliverable may result in Prize forfeiture and an alternate winner shall be selected. If a potential winner is ineligible to win the Prize because of age or other material misrepresentation, does not comply with the acceptance requirements above or is otherwise in violation of these Official Rules, then such winner will be disqualified and an alternate winner may be selected from the remaining eligible entrants. No substitution or transfer of a prize is permitted except by BGCNP.

As the winner of the 2022 raffle event, there are 3 prize options for your consideration.

- 1. Old Hickory Lodge 10' x 16' Playhouse Shed
 - For non-cash prizes, the winner pays 25% of the fair market value of the prize minus the amount of the wager. Taxes are submitted to the organization (BGC) to be submitted to the IRS.
 - IRS Notice 1340 Reporting Requirements for Non-profit Organizations
 - BGC will submit the 25% tax to the IRS via Form W-2G
 - Fair Market Value = \$7,305.90 \$30 ticket cost = \$7,275.90
 - \$7,275.90 x 25% = \$1,818.98 tax due before taking possession of the Shed
- 2. \$3,500 credit towards a different Old Hickory brand shed at Ramsdell's
- 3. \$3,000 cash to be paid to winner via Cashier's Check
