There were a total of 1414 ballots cast

Article 1: To elect the following officers to serve from their election and qualification for **one year** or until the election and qualification of their successors. (Australian Ballot)

- **Serena Parker** was elected **District Clerk**
 - **1230-yes votes Overvotes-1 Undervotes-175 Write-in-8**
- **Dianna Simpson** was elected **Treasurer**
 - **1241-yes votes Overvotes-1 Undervotes-165 Write-in-7**
- **Gail Paquette** was elected **Asst. Treasurer**
 - **1220-yes votes Overvotes-0 Undervotes-190 Write-in-4**

Article 2: To approve compensation, to be paid to District Officers. (Australian Ballot)

- Clerk-\$1,000
 - **PASS 1040-yes votes 228-no votes Overvotes-2 Undervotes-144**
- Treasurer-\$5,000
 - **PASS 990-yes votes 273-no votes Overvotes-4 Undervotes-147**
- Asst. Treasurer-\$1,000
 - **PASS 1024-yes votes 239-no votes Overvotes-0 Undervotes-151**

Article 3: To elect nine (9) school directors from the nominees to serve on the Kingdom East Unified Union School District Board. (Australian Ballot)

- **Amy McQuade** was elected for **Burke** School Director (three-year term)
 - **Overvotes-0 Undervotes-1195 Write-in-219 (A. McQuade-67)**
- **Kurt Martin** was elected for **Concord** School Director (three-year term)
 - **Overvotes-0 Undervotes-1303 Write-in-111 (K. Martin- 59)**
- **Desmond Brown** was elected for **Lunenburg** School Director (three-year term)
 - **785 -Yes**
 - **Overvotes-4 Undervotes-621 Write-in-4**
- One (1) school director who is a resident of **Lunenburg** School Director (one-year term)
 - There were not a sufficient number of write in votes for one person (min of 30) to qualify a position
 - **Overvotes-0 Undervotes-1366 Write-in-48**
- **Lawrence Golden** was elected for **Lyndon** School Director (three-year term)
 - **959 -Yes**
 - **Overvotes-0 Undervotes-430 Write-in-25**

- **Steve Smith** was elected for Lyndon School Director (two-year term)
 - **867 -Yes**
 - **Overvotes-0 Undervotes-534 Write-in-13**

- One (1) school director who is a resident of Lyndon School Director (one-year term)
 - There were not a sufficient number of write in votes for one person (min of 30) to qualify a position
 - **Overvotes-0 Undervotes-1358 Write-in-56**

- **Bill Coleman** was elected for Newark School Director (three-year term)
 - **852 -Yes**
 - **Overvotes-1 Undervotes-548 Write-in-13**

- **John W. Simons** was elected for Sheffield School Director (two-year term)
 - **813 -Yes**
 - **Overvotes-1 Undervotes-539 Write-in-61**

Article 4: Shall the voters of the Kingdom East Unified Union School District approve the Board of School Directors to expend \$53,401,362 which is the amount the Board has determined to be necessary for the ensuing fiscal year? The Kingdom East District estimates that this proposed budget, if approved, will result in per pupil education spending of \$14,867, which is 7.99% higher than per pupil education spending for the current year. (Australian Ballot)



(Australian Ballot)
