<b>Amended Fee</b> - immediate disposition with notices and office directives	\$590.00
<b>Coordinating Activities, Rites and Ceremonies</b> - coordination of all activities, scheduling with clergy, organists, pipers, cemetery or crematorium representatives, caterers or other reception facilitators, coroners or other necessary contacts and the preparation and placing of death notices in newspaper and website.	\$200.00
<b>Documentation</b> - completion and filing of all documents necessary to carry out the services and supplies requested, including but not limited to, death registration, burial permit, coroner's certificate for cremation, documentation necessary to transport body (if applicable). <b>Transport Remains</b> - the transfer of the deceased (within 50 km radius) from place of death to Fawcett Funeral Home. Additional mileage \$2.00/km. <b>Basic Preparation of Remains</b> - the preparation of the body for placement into the casket, including bathing, dressing and the setting of facial features for identification or viewing without embalming. Fawcett Funeral Home reserves the right to restrict viewing of unembalmed bodies.	\$250.00

<b>Embalming of Remains</b> - embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration and temporary preservation. Embalming is not legally required, but may be recommended to preserve the body between the time of death and the visitation or disposition of the deceased. Our professional funeral directors will make a recommendation based on the condition of the body and expected service needs.	\$400.00
<b>Removal of Pacemaker or Implant</b> - required with cremation removal will carried out by a licensed professional. Safe storage and transfer for disposal of device as required.	\$50.00
<b>Facilities for Preparation / Embalming / Shelter</b> - facilities used to prepare, embalm and shelter the body.	\$250.00
<b>Staff Services for Visitation</b> - staff to coordinate and oversee the visitation for an initial period up to 2 hrs.	\$300.00

# Disbursements

Disbursements are items requested or required in the provision of funeral services for the Recipient as may be ordered by the funeral home as agent at the request of and on behalf of the Purchaser. These items may be arranged or procured by the funeral home on behalf of the Purchaser or many may be secured directly by the Purchaser thus avoiding the addition of HST or additional HST. Disbursement costs are generally due upon order and/or prior to delivery. The funeral home may offer to provide payment for disbursements on behalf of the Purchaser if authorized. However, the responsibility for payment remains with the Purchaser whether it be provided directly to the supplier of the disbursement or the funeral home when acting as "Agent for the Purchaser". The purchaser acknowledges that disbursements listed on the funeral service contract represent an estimate only and the actual reconciled costs will be disclosed with the final statement of account.

The funeral home and the Purchaser acknowledge that the funeral home will be acting as "Agent for the Purchaser" with respect to those disbursements for which payment is extended by the funeral home in accordance with the terms of the authorized agreement and funeral service contract.

## *Disbursements Required or Requested may include but are not limited to:*

### ***Bereavement Authority of Ontario (BAO) Consumer Protection Fee***

The fee is charged by the Bereavement Authority of Ontario (BAO) in order to provide its services of information on your options in bereavement services and to regulate the profession making sure the law is consistently followed. The BAO's regulatory work includes responding to public complaints, inspecting and providing guidance to bereavement businesses and professionals, which it licenses across Ontario to better serve you – the public. The BAO is wholly funded by licensee fees (not tax dollars).

## Payment Terms at Time of Need

The PURCHASER promises to pay the balance due to the funeral home in full within thirty (30) days from the date of the contract. If payment in full is not received within thirty (30) days a charge of 2% per month, compounding monthly (26.82% per annum) will be applied to any balance due, until full payment is received. Cash, cheque, credit, debit, and e-transfer are accepted methods of payment. Taxes as applicable.

A deposit will be required at the time of the At-Need arrangement conference. The amount of the deposit will reflect 25% of the total contract value, inclusive of taxes and disbursements.

Financing: If you feel that payment in full will take longer than the above mentioned terms, additional information is available upon request.

## Pre-Planning Payment Options

For your convenience, we offer two funding options when prepaying services or supplies. When prepaying, you pay for the services and supplies today and the money will be used to pay for the services and supplies when they are delivered at the time of death.

**Trust:** You may invest the money through us and we will place it in trust, where it will accrue interest until the contract is fulfilled (when the services and supplies are delivered) or the contract is cancelled. This is done by Pre-Authorized Debit Agreement.

**Insurance:** You may purchase an insurance contract where the proceeds of the insurance contract will be used to pay for the services or supplies at the time they are delivered or the contract is cancelled.
