ELIGIBILITY:	MEET TYPE: (Open) Open to all registered USA Swimmers. No swimmer will be permitted to compete unless the swimmer is a member of USA Swimming as provided in USA Swimming Rules and Regulations, Article 302.
SWIMMERS WITH A DISABILITY:	Athletes with a disability are welcomed, but advance notice of desired accommodation must be provided to the Meet Referee via the <a href="NECESSARY ACCOMODATIONS FORM">NECESSARY ACCOMODATIONS FORM</a> , which should be submitted by the entry deadline. Failure to provide advance notice may limit the host's ability to accommodate all requests.
ENTRIES:	Swimmers may swim up to 5 events per day. Time trials will be included in the daily individual event limit.
CHECK IN:	Positive check-in for the 400 IM and 500 Free will close at the start time of their respective sessions.
CLERK of COURSE:	Clerk of course will open at the start of warm ups:  • Late entries will close 15 minutes prior to the start of the session  • Positive check-in will close at the start of the session  • Time trials will close at the start of each day's 400/500y event.

RULES:	Current USA Swimming Rules will govern this meet.
	<ul> <li>All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.</li> <li>On Deck USA-S registration will be permitted at the discretion of the Meet Director and/or Meet Referee.</li> <li>In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, restrooms, or locker rooms. Per GA Swimming policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.</li> <li>Deck changes are prohibited.</li> </ul>

	<ul> <li>Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li> <li>Operation of a drone or any other flying apparatus is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.</li> </ul>
CREDENTIALS:	Only athletes, USA Swimming certified coaches, and USA Swimming officials, in good standing, will be permitted on the deck. Coaches and Officials should have proof of active USA Swimming membership with them at all times. Parents not working the meet as a volunteer or other position are not permitted on deck.
OFFICIALS:	FST welcomes visiting officials and apprentices and will appreciate help in officiating this competition. There will be an official's meeting 1 hour prior to the start of each session. The official's uniform will consist of a white polo collared shirt, navy blue shorts, skirts or slacks with white socks and white shoes. All officials must present at check in, their current LSC Officials Certification Card; OR a recently completed Apprentice Form; AND proof of current USA Swimming Non-Athlete membership. Credentials may be required for deck access and hospitality.
AWARDS:	Medals will be given to each female and male <b>IMX</b> high point winner by age group (10&U, 11-12, 13-14, 15-16, 17&O). Trophies will be awarded to the top 3 overall <b>IMX</b> high point winners.
SCORING:	Scoring for the meet will be based on the HYTEK single-year age group point system. Simmers are NOT limited to their IMR/IMX events, however, to be eligible for the IMX awards, a swimmer must enter and swim all of the IMX events for their age group. Swimmers will only receive scores for their IMR or IMX series of events.
