1	General Permit Requirements City of Burlington Building Permits: All permits or licenses necessary for the new construction or alterations to the structure must be obtained and paid for by the Contractor before starting work. Contractors and Subcontractors are responsible for obtaining any progress or final inspections from the Building Department. Failure to call for required inspections or proceeding without inspection may result in suspension from future bidding. Two copies of all permits are required, one shall be publicly displayed at the job site for all interested parties concerned, the second shall be on file at Southeast Iowa Regional Planning Commission. The Southeast Iowa Regional Planning Commission has the right to inspect work in progress. These inspections need not be announced in advance.	1.00	\$_____
2	Replace gas forced air furnace - 92%+. Remove existing furnace and dispose of in an approved manner. Prepare heat loss analysis and replace the furnace with new unit sized as indicated by heat loss calculation. Give copy of calculation report to Agency before beginning installation. Include connections to existing gas line. Include thermostat, filters, fan, plenum controls, exhaust and air intake pipe. Add a shut off valve on vertical piping, approximate to the electrical disconnect and readily accessible. System to be installed on a separate power circuit. Supply operating manual, operating instruction to the owner and one year call back. Minimum efficiency rating AFUE shall be 92 percent. Replacement unit shall be properly sized in accordance with ACCA's Manual J or other recognized methodology. 3	Install high efficiency 40 gallon hot water heater. Gas Install a 40 gallon, glass-lined high-recovery hot water tank with power vented exhaust. Tank shall be insulated to R10 minimum. Include temperature and pressure relief valve, discharge tube to within 4 inches of the floor, vent, thimble and gas piping from shut-off valve to the tank. Water supply line into tank to have fullway valve installed if not already present. All work to comply with current applicable codes. Remove and dispose of old heater in an approved manner. Tank shall have a minimum 5 year warranty. 4 Replace sidewalk panel, add fill to base.

Remove sidewalk panel on east side of the house by the rear door, where there is deterioration from a well which was formerly plugged. Remove the panel to the nearest joints, approximately 4'x3'. Add and compact crushed stone fill to small hole in ground where settling has occurred. Pour new 4" sidewalk panel of same size as the removed panel with 1/2" rebar on 2ft grid over 3" of compacted gravel base.

5 Install vinyl thermopane double hung window.

Remove and Replace 3 vinyl double hung windows.

- 1 window on E side of house, near front. (Not the window on the south side of the front porch, and not the window near the back door. Replace the window on the south side between the front porch window and the window by the back door.)
- 1 window on the north side of the house
- 1 window on the west side of the house, on the south face of the west wing.

Remove and dispose of entire old window assembly. Provide and install a new prefabricated, double-hung, insulated thermopane, vinyl window, including self-storing screen, of approximate equal size of windows to be replaced. Install flashing and sealing as necessary to provide a sealed, weatherproof, properly flashed installation. If interior trim is disturbed, replace or repair as necessary. Caulk and paint interior window trim as necessary to provide professional finish. Remove all labels from glass. Clean glass pane.

6 Install vinyl thermopane casement window.

Remove and replace one casement window in the bathroom on east side of the house.

Remove and dispose of entire casement window assembly. Install a new double pane energy efficient vinyl casement window of equal size and configuration as original window. Properly flash and seal the window. Install insulation between window frame and rough framing. Reinstall existing interior window trim, or provide new as necessary.

Warranty is to be given to the Homeowner.

7 Install vinyl replacement thermopane double hung window. No trim.

Remove and Replace 2 windows. 1 located in east gable and 1 located in west gable.

Remove and dispose of sash and parting beads. Carefully remove interior stop, preserving for re-use. Remove pulley assembly and weights, if present, and fill cavity with fiberglass insulation. Cover pulley opening with coil stock or flashing. Caulk seams of weight cavity cover. Provide and install a prefabricated, double-hung, double glazed/thermopane, vinyl replacement window, including self-storing screen. Caulk blindstop and the edges to seal. Reinstall interior stops and caulk tight against window assembly. Remove all labels from glass. Clean glass pane.

Note: If there is any conflict in specifications, the window shall be installed according to manufacturers instructions unless otherwise indicated by the agency. Warranty is to be given to the Homeowner.

8 Remove Siding, Asbestos containing material (ACM) abatement.

Siding is assumed to contain asbestos, either remove siding using required safe work practices and licensed asbestos abatement workers, or test siding to verify that it does not contain asbestos and remove without using safe work practices and licensed asbestos abatement workers. If the siding is tested and found to not contain asbestos, notify the agency immediately. A change order will be issued to remove the requirement to removed the siding using proper methods, and to reimburse asbestos test expenses to the contractor.

Using all required safe work practices and licensed asbestos abatement workers and licensed asbestos abatement contractors, remove all siding or other **ACM** as identified in the asbestos inspection report, and dispose of in proper manner, at a preapproved disposal site. Provide housing department with receipts to document proper disposal. Maintain containment requirements to avoid contamination of other areas or neighboring properties. All regulations concerning the removal and disposal of **ACM** must be followed by the contractor, including proper notification to the IDNR and all other applicable agencies.

9 Install vinyl siding, with fanfold, wrap all trim. No fascia/soffit/gutters.

Siding disposal and removal is included under a different line item; costs for removal should not be included in this item.

Preserve soffitting, fascia, and gutters; Do not remove soffitting, fascia, or gutters.

Install on entire exterior, including wrapping all cornice and corner with minimum .040 gauge vinyl installed over fan fold insulation. All door and window trim must be cased. Aluminum shall be installed on windows and door trim, and all porch ceilings. Preformed fascia trim shall be used where applicable. Inside and outside corner posts, service meter blocks, replacement vents, plumbing and electrical blocks in matching color shall be used as required. Caulk all seams with silicone caulk., beads not to exceed 3/8". Siding must carry a nonprorated, transferable manufacturer's limited lifetime warranty. All installation procedures, including spacing, shall be in accordance with manufacturer's specifications. Owner to have choice of color.

Install siding over boarded window on rear of house.

NOTE: You must have a licensed electrician remove and reinstall the electric conductors attached to the house.

Square feet is estimate only. Contractor responsible to determine amount of materials needed provide price for complete project.

11 Install Insulated Steel Door, complete with lite.

For exterior door.

Remove existing door. Install steel door and frame assembly, complete with lockset and deadbolt all hardware including doorstop. All exterior door locks to a house or suite to be keyed-alike. Door shall fit existing opening. Reduction in opening size shall not be permitted. Door shall have at least one lite of minimum 24" x 36". Unit shall be primed and painted one color, customer has choice of color. Repair all damage to walls and trim.

12 Install aluminum or vinyl combination storm door.

Install 2 storm doors, one on front door and one on rear door.

Install aluminum or vinyl wood core storm door with continuous hinge, 3/4 hight lite. Door to have combination storm and screen panel in passing tracks or shall be equipped with removable panels. Door to be equipped with latching handle, bottom sweep, and pneumatic closer. Door to fit opening completely. Reducing the door opening size shall not be permitted. Adjust and test closing operation.
