1 General Permit Requirements

City of Wapello Building Permits:

Any permits or licenses necessary for the work specified herein must be obtained and paid for by the Contractor before starting work. Contractors and Subcontractors are responsible for obtaining any progress or final inspections from the Building Department. Failure to call for required inspections or proceeding without inspection may result in suspension from future bidding. Two copies of all permits are required, one shall be publicly displayed at the job site for all interested parties concerned, the second shall be on file at Southeast Iowa Regional Planning Commission. The Southeast Iowa Regional Planning Commission has the right to inspect work in progress. These inspections need not be announced in advance.

Install vinyl replacement thermopane double hung window. No trim.
Remove and Replace all windows except the upper story window on the north side of the house, for a total of 13 windows. 1 on north side, 5 on west, 4 on south, and 3 on east.

Remove and dispose of storm windows. Install coil stock trim on exterior to cover wood exposed by removal of storm windows. Coil stock to match adjacent trim as close as possible, but a perfect match won't be possible. Coil stock to be installed in a neat, workmanlike manner and to be water tight.

Remove and dispose of sash and parting beads. Carefully remove interior stop, preserving for re-use. Remove pulley assembly and weights, if present, and fill cavity with fiberglass insulation. Cover pulley opening with coil stock or flashing. Caulk seams of weight cavity cover. Provide and install a prefabricated, double-hung, double glazed/thermopane, vinyl replacement window, including self-storing screen. Caulk blindstop and the edges to seal. Reinstall interior stops and cault tight against window assembly. Remove all labels from glass. Clean glass pane.

Note: If there is any conflict in specifications, the window shall be installed according to manufacturers instructions unless otherwise indicated by the agency. Warranty is to be given to the Homeowner.

PRODUCT STANDARD: Fusion-welded, low - E glass with low-conductance spacer a minimum of 3/4" and a U-factor rating of 0.30 or below; and a lifetime limited warranty. Simonton Prism series; ThermaStar by Pella®; or other equal quality window approved by the agency.

Windows must have overridable opening limiters to prevent accidental falls.

Install fiberglass or acrylic shower unit complete (60").

Remove and dispose of old tub and shower surround. Prepare area to receive new 60" wide by 30" deep walk-in shower. Remove wall material as necessary to facilitate installation of new shower. Ideally, wall material would be removed only to corners or other natural breaks. There is a makeshift linen closed on the valve side of the existing tub/shower. This linen closet can be reduced/increased as necessary to make room for the new shower. The bathroom has a drop ceiling over the top of the walls; this condition can remain in place, making it simple to modify walls to accommodate the new shower.

Remove only the minimum laminate floor planks necessary to facilitate installation of the new shower, leaving unaffected flooring planks in place. The customer has plenty of extra matching floor planks to trim to fit and install when shower is installed.

Install 60"-wide fiberglass shower stall unit complete with faucet assembly, riser, curtain w/rod and 2.75 gallon per minute shower head. Shower will need to be a multi-piece assembly. Shower stall unit to have a small curb and molded-in-place corner shelves. Install a grab bar on the opposite wall from the mixer and shower head. Shower valve shall be provided with an automatic safety mixing device to prevent sudden unanticipated changes in water temperature. (OPC 425.4) Set and frame to manufacturer's specifications.

Frame and finish walls as needed to blend with room walls. Match texture as close as possible to adjacent texture. Ok to break joints at corners or other natural transitions such as corners. Paint new wall surfaces to match as close as possible. Exact color match not required. Reinstall trim as necessary.

4 Front and Rear Porch Roofs: Tear off, reshingle. Repair rear porch fascia.

Recover front and rear proch roof surfaces on house. The main house has already been replaced. Remove down to sheathing. Replace defective, rotted and/or deteriorated sheathing to match existing up to 10% of roof area. If more than 10% call for approval by agency for additional work. Install felt roofing underlayment with top lap of 2" and end lap of 4". Install drip edge at eaves first and finish with drip edge along the rakes. Call for inspection before installing shingles (to be made within 24 hours). Install 3 tab, or laminated architectural, square butt, self-sealing fiberglass strip shingles with a 30 year warranty. Joints to be staggered in6 courses. Do not use staples for installation of shingles. Replace all flashing with .019 aluminum coil stock, including valleys, and where roof line meets wall of higher elevation.

Inspect all fascia; replace where rotted or unstable. There is an area on the rear porch which needs replaced. Prime any new wood installed. Paint new fascia to match surrounding as close as possible, or install aluminum fascia, color selected by owner, over repaired fascia.

Provide copy of manufacturer's instructions and warranty to Homeowner.

Contractor responsible for proper disposal of all old roofing material and construction debris.
