3. <u>1099 FORMS</u>

- Internal Revenue Service (IRS) Form 1099s are sent out by the Office of Shared Services (OSS), a division of the Office of Budget and Management. The forms are required to be sent out by the end of January. The Ohio Department of Developmental Disabilities (DODD) does not send out or have access to IRS Form 1099. DO NOT CALL DODD for your 1099 FORMS
- If you do not receive your IRS Form 1099 or need to request a duplicate, please contact the Office of Shared Services directly.
- Please note that the <u>Office of Shared Services</u> must have your valid mailing address, and if a
 1099 is returned to OSS for any reason, OSS will inactivate your account in OAKS. If
 your account is inactive, you will not receive payment. It is your responsibility to maintain
 a current mailing address with the Office of Shared Services, as well as the Ohio Department of
 Developmental Disabilities.
- You can update your mailing address, or check to ensure OSS has your current address, by going to the Supplier Portal system available on the OSS website.
- Independent providers who made over \$600 during the previous calendar year and are certified under your Social Security Number, should receive an IRS Form 1099-NEC (Nonemployee Compensation). Income will be reported in Box 1 of the form.

4. DODD New Annual Training Requirements Allow for Flexibility

- DODD has developed <u>guidance</u> on the annual training requirements in non-licensed settings and an <u>optional form</u> to assist providers in documenting training.
- This can be helpful for documenting training that does not provide a certificate or other proof of completion. The form also meets the requirements for training documentation included in 5123-2-08 (F)(2).
- Training does not need to have CPDs/CEUs to count toward the annual training requirements.
- Providers should plan ahead to ensure annual training requirements are met by 12/31/22 and annually thereafter.

5. Templates for Training Plans – Agencies only

- Changes to OAC 5123-2-08 require agency providers to develop written training plans for the director of operations, supervisors of direct support professionals, direct support professionals, and some volunteers. These changes were designed to allow providers more flexibility to seek out training that will help them better provider person-centered services.
- DODD has created optional templates that can be used for developing and documenting these training plans that can be found here.
- Agency providers should plan ahead and ensure that training plans are developed, and training completed by December 31, 2022 and annually thereafter.

6. Shared Living Guidance & Appendix K

- DODD is providing guidance in response to questions that have been asked shared living services.
- Many of the incoming questions and concerns are surrounding the temporary flexibilities offered to this service through Appendix K due to the Public Health Emergency
- As stated in Section (D) (1) of the rule: "Shared living shall be authorized for an individual when one or more adult caregivers who reside with the individual provide twenty percent or more of the individual's personal care and support services." All caregivers residing in the home are included in the twenty percent calculation. Therefore, the relief Homemaker/Personal Care (HPC) provider, allowed by Appendix K, should be a provider that does not reside in the home.
- Appendix K allows for HPC to be authorized on the same day as Shared Living. This temporary flexibility is intended to provide relief to the Shared Living provider. The care given by the HPC provider should not be at the same time as the Shared Living provider (i.e. no 2:1 staffing).

- DODD is getting caught up with but there has been a big influx of applications in the past couple weeks
- When it comes to renewals, DODD may tell providers that their certification will not have a gap in the if they submitted their re-certification prior to expiration this does not mean there won't be a gap in ability to bill
- Providers must submit their renewal of certification at least 45 days prior to expiration in order for DODD to guarantee they will back date a provider's re-certification date and this is assuming ALL required documentation was turned in prior to expiration.
- There may still be a gap in when a provider can bill as DODD may take longer than 45 days to review renewal request. At this time, they are indicating they will back date so the provider can back bill.
- DODD has stated they will extend the current span if a provider applies for renewal 45 days prior to expiration if there is a problem and DODD is not able to review the renewal for some reason. All other requests for extension are looked at on a case-by-case basis.
- Remember Applications for recertification can be started 90 Days in Advance! We recommend that is when you submit your applications!!
 - We do not have a date at this time when the PSM Application will close in order for PNM to get up and running. We will keep you posted as soon as we have any further information.

- DODD's Provider Services Management (PSM) system is now accepting Agency Initial
 Applications. A recent announcement made by the Ohio Department of Medicaid (ODM) related
 to the implementation of the Provider Network Management (PNM) module, the planned single
 point of entry for Medicaid provider certification and credentialing, has allowed DODD to
 resume agency application processing.

1. Shared Living Memo Monday Update

- Shared living providers cannot also act as natural support for the people to whom they provide shared living services. Shared living is a daily service and providers of this service must comply with the requirements in OAC 5123-9-33 and any other provisions applicable to the services they provide
- The personal funds rule, OAC 5123:2-7-07, therefore applies to shared living providers who are responsible for assisting people with personal funds. This rule applies regardless of whether the shared living provider is related to the person to whom they are providing shared

- living. Individual service plans (ISPs) should not identify shared living providers as natural supports for the person to whom they provide shared living. Other people residing in the home who are not the person's certified shared living provider may provide natural supports
- Please note that the Ohio Revised Code specifically allows family delegation and for some related providers to administer medications without certification. Because this is authorized by law, it is not considered a natural support. More information about these allowances can be found here

5. Provider Retention Program has been Approved!

- Last week DODD shared that CMS approved the Appendix K application allowing for the 6.5% retention payment program that had been in discussion over the past few months.
- This is a County Board funded initiative and all 88 Counties will be participating.
- While the program has been approved, the start date has yet to be set. DODD has filed a rule you can find <u>HERE</u> that will allow the program to go into effect.
- Once the program rolls out, DODD had indicated they will provide training, FAQs, and other resources for providers.
- As a short overview, the draft rule indicates the following:
 - The retention payment is meant for the following services: Adult day support; Career planning; Group employment support; Homemaker/personal care; Homemaker/personal care daily billing unit; Individual employment support; Non-medical transportation; Participant-directed homemaker/personal care; Shared living;
 - Transportation; and Vocational habilitation.
 - An independent provider in good standing that has been reimbursed for provision of one or more of the home and community-based services listed during the applicable quarter is eligible and will receive a retention payment for that quarter. The independent provider need not take any action to participate in the retention
 - payment program; the department will issue retention payments to eligible independent providers in accordance with paragraph (F)(1) of this rule
 - An agency provider or residential facility in good standing that has been reimbursed for provision of one or more of the home and community-based services listed during the applicable quarter is eligible to receive a retention payment for that quarter when the agency provider or residential facility:
- Opts to participate in the retention payment program by affirming, via the department's webbased portal for the retention payment program, on or before the fifteenth day of the first month of the quarter for which it will begin to participate, its intent to participate and assurance that it will comply with this rule;
- Disburses to each of its eligible direct support professionals, on or before the fifteenth day of the third month of the quarter, a portion of the retention payment issued by the department, as calculated by one of the methods described in paragraph (F)(3) of this rule; and
- Submits, via the department's web-based portal for the retention payment program, on or before the fifteenth day following the quarter:
 - Information requested by the department regarding the retention payment program including, but not limited to:
- Disbursement of the retention payment to its direct support professionals; and
- Any portion of a retention payment used to cover costs associated with implementation or administration of the retention payment program and therefore not disbursed directly to its direct support professionals.
 - An attestation that the retention payment was used and disbursed to direct support professionals in accordance with this rule.
- There are further instructions regarding opting in, use of payments, who is eligible to receive retention payments, record keeping and so on in the draft of the rule. As indicated above, once approved, there will be trainings available.

The email is intended to alert those MRC providers that a change to the HPC/OSOC services they are delivering has occurred.

3. Federal Public Health Emergency Officially Renewed

- The Secretary of Health and Human Services (HHS) has recently renewed the determination that a federal public health emergency (PHE) continues to exist. This was previously scheduled to expire on October 12, 2022. The declaration lasts for the duration of the emergency or 90 days, but may be extended by the Secretary.
- When Appendix K was approved, it included an additional six months beyond the end of the federal public health emergency to allow for unwinding of the temporary flexibilities and the return to permanent/ongoing services. Appropriate services should be determined through the person-centered team planning process to determine which service(s) best meets the needs of the individual and to have the service(s) set up and in place before the end of the six-month unwinding period.

1. Provider Retention Payment Updates

- The Ohio Department of Developmental Disabilities (DODD) is launching the county board-funded Direct Support Professional (DSP) retention payment initiative for independent providers and DSPs of agency waiver providers.
- Because the initiative is retroactive to July, initial payments will cover three quarters of payments. This will allow DODD to expedite payments allowing funds to get out sooner and will put the initiative on schedule with rule requirements by April. DODD will stagger the three initial payments to providers, which will assist providers in tracking how funds are passed along to DSPs. The table below shows how the first payments will be issued:

Provider agencies and independent providers will receive the first payments in mid-January. Eligible DSPs employed by agency providers will receive payment from their employers by mid-March. Agency DSPs should talk with their employer to determine when they will receive their retention payments.

2. Changes Coming to DSP Courses in DODD MyLearning January 1

- At 9 AM on January 1, 2023, the following changes will be live in DODD MyLearning:
- The MyLearning homepage will have four options (rather than six) for Courses for Direct Support Professionals. Separate categories for DSPs at licensed facilities are no longer needed because the DSP training requirements in the licensed residential facilities rule are now in line with the DSP training requirements for waiver settings.
