Keith's Law - Form Available

Ohioans with disabilities may now voluntarily register in a secure, statewide database that helps provide information to first responders. Help those interested complete this form and learn more on the DODD's website.

Additionally, any person who regularly has someone with a communication disability in their vehicle can voluntarily enroll in this database that connects to the Law Enforcement Agencies Data System (LEADS). The law enforcement can then be made aware that a person in the vehicle might have difficulty communicating and can approach the vehicle with awareness to reduce any potential misunderstandings. To enroll, complete the verification form.

1099 FORMS Confirm Accurate Contact Information

Ohio Shared Services will be mailing out 1099 tax forms in January. Providers should ensure that their address within the system is accurate. 1099 forms that are returned due to address issues will cause payment accounts to be moved to inactive and Ohio Shared Services will not issue payments until the address is updated.
