1. Touring Difficulty – Is This Tour Right for You?

Before registration, please consider this important information:

- Although porterage service are provided, you may need to carry your luggage on occasion.
- While touring, you will be boarding and getting off the vehicle several times per day.
- Some of the days will entail several hours of walking on even and uneven pavements or roads, ascending and descending stairs (sometimes without railings), walking up or down hills, or standing in place for 30-60 minutes at a time, while listening to the guide's explanations.
- We regret that this tour is not suitable for guests with mobility limitations. The tour staff is not medically trained and cannot provide any assistance with traveler mobility.
- Vehicles, hotels and sites visited on this tour are not ADA-compliant.
- In Cairo, climbing into tunnels in the Pyramids may be claustrophobic, and breathing may be difficult.
- In Luxor, tombs in the valley of the Kings may be claustrophobic and breathing inside may be difficult.
- Some of the days may entail drives of 3 hours or longer with breaks every 2 hours.
- Some flights in Egypt are scheduled for early mornings, requiring waking up around 2:00-3:00 AM.
- Smoking is commonplace, including indoors at hotels and restaurants (only outdoors on Nile cruise).
- Cairo may have a “blanket” of smog in the morning, usually clearing by midday.
- You may skip touring days. There will be no refund for unused services, entrance fees or meals.
- May – September daytime temperatures in Egypt can be higher than 100°f (38°c).
- Food allergies or requirements will be forwarded but may not be properly addressed. It is the responsibility of the participants to be diligent about their food.

2. Package Start Dates in 2026 (arrival in Cairo):

This package is available for arrival in Cairo **every Tuesday**.

Important:

Once you have completed the online registration form and paid your initial deposit, a request will be sent to the service providers to confirm the hotel accommodation and the flights included in this package (Cairo – Luxor / Aswan – Cairo). A confirmation email will be sent separately. **Please do not purchase your international flights until you have received the confirmation email.** If space is not available at the hotel, cruise or on the domestic flights in Egypt for your chosen date, you will be contacted with other available options, or you may opt to cancel your reservation with a full refund of your initial deposit.

3. To Register for the Tour:

Registration for the tour is open via the dedicated, secure tour website.

Please have the following information/documents available prior to registration:

- Your passport (must be valid for at least 6 months beyond the date of return).

6. Included in the Package/Tour Cost:

- **Hotels (may be substituted for hotels of similar quality):**
 - 4 Nights [Sofitel Cairo Downtown Nile](#) in Cairo (Deluxe Nile rooms)
 - 4 Nights [Steigenberger Minerva Nile Cruise](#) (Standard cabins)
 - See upgrade option to suite on the cruise.
- **Meals:**
 - 4 Hotel breakfasts and 4 hotel dinners in Cairo
 - All meals (full board) on the Nile cruise.
- **Touring and transportation:**
 - Arrival and departure airport transfers with a local representative.
 - 3 days of touring in Cairo with a licensed, English-speaking guide in a 12-seat, air conditioned van.
 - Group bus excursions offered by the cruise, with licensed, English-speaking guides.
 - Entrance fees to sites and/or activities listed in the itinerary.
- **Flights:**
 - Roundtrip flights on Egypt Air: Cairo – Luxor/Aswan – Cairo

7. Not Included in the Tour or Package Cost:

- Generally speaking: Any service or tour component not mentioned above as included, is not included. This refers to any **international airfare**, touring and meals not part of the itinerary, drinks during meals, passports, visas, expenses of a personal nature such as gifts, mini-bar purchases or cell phone expenses (calls, data roaming).
- **Flights to/from Egypt: please do not purchase flights until the package is confirmed.**
- **Travel insurance.**
- **Visa to Egypt (\$25 payable in cash at the airport on arrival)**
- **Tips: Approximately \$200 per person for hotel and cruise staff, drivers and guides.**

8. Payment Schedule, Terms and Conditions:

- A. By registering and paying, you signify that you represent the travel party and have read, understand, and agree to all sections of this brochure and Disclaimer below.
- B. **Important payment dates to remember:**
 - a. **Upon Registration:** A non-refundable deposit of 20% of the total package cost.
 - b. **90 Days Prior to Arrival:** Additional non-refundable deposit of 50% per person.
 - c. **45 Days Prior to Arrival:** Final payment is due and is non-refundable.
- C. **Refund periods (if you cancel):**
 - a. Cancel within 1 day of reservation: Fully refundable.
 - b. Cancel 91 days or more prior to arrival: 20% of the total package cost is non-refundable.
 - c. Cancel 46-90 days prior to arrival: 70% of the total package cost is non-refundable.
 - d. 45 Days or less prior to arrival in Cairo: All payments are non-refundable.
- D. **Cancellation of the tour by Scopia LLC:**
 - a. In the event a specific tour departure cannot be confirmed due to no availability at the hotels, Nile cruise or on the domestic flights in Egypt, you will have the option to rebook to a different arrival date or receive a full refund.
 - b. Should the tour be cancelled due to reasons or events beyond the control of Scopia LLC (force majeure): Scopia LLC will work with tour suppliers for possible reimbursement of payments made to the suppliers. Amounts received by Scopia LLC will be reimbursed to tour participants less \$200 per person to cover time and expenses by Scopia LLC.
- E. **Important note: Payment and refund schedule and/or amounts may change if certain suppliers require deposits (refundable or non-refundable) which are not listed above.**
- F. There is no refund for unused services while traveling.
- G. Scopia LLC has the right to refuse participation to any registrant, for any reason and without the need to disclose such reasoning.
- H. Scopia LLC has the right to cancel reservations made on behalf of participant(s), without refunding payments made, should a participant fail to pay deposits or final payments by the due dates.
- I. Cancellations must be received in writing.
- J. Credit Card Chargebacks - Payments by credit card do not change these Terms and Conditions. Prior to initiating a "chargeback" with the credit card company, please try to resolve any disputes with Scopia LLC directly. In the event of a "Chargeback" investigation finding in favor of Scopia LLC, the customer will be charged a \$100 administrative fee for each "Chargeback".
- K. Credit card refunds do not include the 3% agency processing fee.
- L. Insurance costs are not reimbursed by the insurance company in case of cancellation(s) and filing of a claim due to a covered reason.
