1. Touring Difficulty – Is This Tour Right for You?

Before registration, please consider this important information:

- Although portage service will be provided, you may need to carry your luggage on occasion.
- Some of the days will entail 5-9 hours of driving with planned break along the way.
- You will be boarding and getting off the vehicle 4-6 times per day, during touring days.
- Some of the days will entail several hours of walking on even and uneven pavements or roads, ascending and descending stairs (without railings), walking up or down hills, or standing in place for 20-30 minutes at a time, while listening to the guide's explanations.
- We regret that this tour is not suitable for guests with mobility limitations. The tour staff is not medically trained and cannot provide any assistance with traveler mobility.
- Vehicles, hotels and sites visited on this tour are not ADA-compliant.
- Vehicles, hotels or sites on the tour are not ADA-compliant.
- It is possible to skip sites and stay in the hotel, with no refund for unused entrance fees.
- Temperatures can vary widely between daytime and nighttime, as well as between locations.
- Traveling in the Atlas Mountains entails winding roads and altitudes up to 7,000 feet.
- Do not drink tap water and avoid uncooked/unpeeled fruits and vegetables.
- Smoking is allowed indoors (such as in hotel lobbies).
- Souvenir peddlers at tourist sites can be a bit intimidating. Learn to say "no".
- Food allergies will be noted and forwarded but may not be properly addressed.
- Medical facilities may be limited in remote areas.

2. Package Start Dates in 2026 (arrival in Marrakech):

This package is available for arrival in Marrakech any day.

Important:

Once you have completed the online registration form and paid your initial deposit, a request will be sent to the service providers to confirm the hotel accommodation. A confirmation email will be sent separately. **Please do not purchase your international flights until you have received the confirmation email.** If space is not available for your chosen date, you will be contacted with other available options, or you may opt to cancel your reservation with a full refund of your initial deposit.

6. Included in the Package/Tour Cost:

- **Hotels (Standard rooms. Hotels may be substituted for similar quality):**
 - 2 Nights [Hotel Savoy](#) in Marrakech.
 - 1 Night [Berbere Palace Hotel](#) in Ouarzazate.
 - 1 Night [Lemnaouar Camp](#) in Merzouga (tent).
 - 2 Nights [Riad Fes](#) in Fes.
 - 1 Night [Dawliz Hotel](#) in Rabat.
 - 2 Nights [Hotel Savoy](#) in Marrakech.
- **Meals:**
 - 9 Buffet breakfasts and 7 buffet dinners at hotels.
 - 2 Restaurant dinners (Marrakech and Fes)
 - 1 Lunch in Essaouira
- **Touring and transportation:**
 - Arrival and departure airport transfers with a local representative.
 - Fast Track service on arrival and departure – skip the lines.
 - 8 Days of touring with a licensed, English-speaking guide in an air-conditioned van with a separate driver.

7. Not Included in the Tour or Package Cost:

- Generally speaking: Any service or tour component not mentioned above as included, is not included. This refers to any **international airfare**, touring and meals not part of the itinerary, drinks during meals, passports, visas, expenses of a personal nature such as gifts, mini-bar purchases or cell phone expenses (calls, data roaming).
- **Flights to/from Morocco: please do not purchase flights until the package is confirmed.**
- **Travel insurance.**
- **Tips: Approximately \$250 per person for drivers, guides and hotels.**

8. Payment Schedule, Terms and Conditions:

- A. By registering and paying, you signify that you represent the travel party and have read, understand, and agree to all sections of this brochure and Disclaimer below.
- B. Important payment dates to remember:**
- a. **Upon Registration:** A non-refundable deposit of 30% of the total package cost.
 - b. **90 Days Prior to Arrival:** Additional non-refundable deposit of 50% per person.
 - c. **45 Days Prior to Arrival:** Final payment is due and is non-refundable.
- C. Refund periods (if you cancel):**
- a. Cancel within 1 day of reservation: Fully refundable.
 - b. Cancel 91 days or more prior to arrival: 30% of the total package cost is non-refundable.
 - c. Cancel 46-90 days prior to arrival: 80% of the total package cost is non-refundable.
 - d. 45 Days or less prior to arrival: All payments are non-refundable.
- D. Cancellation of the tour by Scopia LLC:**
- a. In the event a specific tour departure cannot be confirmed due to no availability at the hotels, you will have the option to rebook a different arrival date or receive a full refund.
 - b. Should the tour be cancelled due to reasons or events beyond the control of Scopia LLC (force majeure): Scopia LLC will work with tour suppliers for possible reimbursement of payments made to the suppliers. Amounts received by Scopia LLC will be reimbursed to tour participants, less \$200 per person to cover time and expenses by Scopia LLC.
- E. Important note:** Payment and refund schedule and/or amounts may change if certain suppliers require deposits (refundable or non-refundable) which are not listed above.
- F. There is no refund for unused services while traveling.
- G. Scopia LLC has the right to refuse participation to any registrant, for any reason and without the need to disclose such reasoning.

- J. Credit Card Chargebacks - Payments by credit card do not change these Terms and Conditions. International flights are not included in the package costs. **Please do not book your flights before being requested to do so.** You can purchase tickets yourself or with the help of Scopia LLC. Private airport transfers are included so you can arrive and depart on any flight.

Meals included are signified as B, L, D. Kindly note the itinerary is subject to change according to the discretion of the tour company, guide, time constraints or other factors, such as weather.

Important information on Morocco itineraries:

- All museums in Morocco are closed on Tuesdays and on Religious Holidays.
- Bahia Palace in Marrakech is closed during the King's stay in Marrakech.
- All monuments and museums are closed on the morning of religious holidays.
- Sites and/or monuments may be closed without advance notice in case of the King's visit, governmental official visit or the site is rented by TV or film studios for filming.
