### 1. To Register for the Tour:

Registration for the tour is now open via the dedicated, secure form available on the tour website.

The upfront pay now costs are \$100 non-refundable deposit per person. It can be paid by check, Zelle or credit card (added fee). This deposit will be refunded if a minimum of 10 participants is not reached by December 31, 2025.

**Please have the following information/documents available prior to registration:**

- Your passport (must be valid for at least 6 months beyond the date of return).
  - **If you do not have a passport or if your passport expires prior to the end of October 2026, please apply for a new passport.**

**Seller of Travel:** A reminder that Scopia LLC is not registered as a “Seller of Travel” in the states of California, Washington and Iowa. This tour is therefore not offered to residents of the states.

## 2. Touring Difficulty – Is This Tour Right for You?

The tour is not sold or offered as ADA-compliant. Aside from the beautiful sites and lots of fun during our travels, there is important information you should consider:

- While touring, you will be boarding and getting off the vehicle several times per day, during touring days.
- **Some of the days will entail several hours of walking on even and uneven pavements or roads, ascend and descend stairs (sometimes without railings), walk up or down hills, or stand in place for 30-60 minutes at a time, while listening to the guide’s explanations.**
- Please be sure to [review the brochure](#) detailing the levels of difficulty for each shore excursion.
- Many of the sites are not designed to accommodate travelers with walking accessories.
- Some of the days may entail drives of 2 hours or longer.
- The vehicle on the tour is not ADA-compliant but it is air conditioned.
- It is possible to skip sites and stay on the vehicle or in the hotel/cruise, but there will be no refund for unused entrance fees.
- Sailing on a ship in the Mediterranean likely means at least some “pitching” (up/down movement) or “rolling” (swaying sideways).
- April weather is usually comfortable (70’s-80’s) during the daytime and cooler in the evenings (50’s-60’s).
- Food allergies or requirements will be noted and forwarded but may not be properly addressed. It is the responsibility of the participants to be diligent about their food.

## 8. Payment Schedule, Terms and Conditions:

- A. By paying, you signify that you represent the travel party and have read, understood, and agree to all sections of this brochure and Disclaimer below.
  - B. Payments are only accepted by check, wire transfer or Zelle, except for the initial deposits which can be paid by credit card, with an added 3% agency handling fee.
  - C. Check payments should be sent to arrive by the due date to Scopia LLC, 8916 N Iroquois Road, Bayside, WI 53217. Please add "Greece April 2026" to the memo line.
- D. Important dates to remember:**
- a. **Upon Registration and no later than December 31, 2025:** A non-refundable deposit of \$100 per person (credit card or check). **This deposit will be reimbursed if we do not have a minimum of 10 participants registered by the deadline.**
  - b. **January 1, 2026:** If we reach 10 participants, a second non-refundable deposit of \$1,000 per person is due (check, wire transfer or Zelle).
  - c. **February 6, 2026:** Final payment is due and is non-refundable (check, wire transfer or Zelle).
- E. Refund periods (if you cancel):**
- a. Cancel by December 31, 2025: \$100 cancellation fee per person.
  - b. Cancel from January 1, 2026 to February 5, 2026: \$1,100 cancellation fee per person.
  - c. Cancel any time after February 5, 2026: All payments are non-refundable.
- F. Cancellation of the tour by Scopia LLC:**
- a. In the event the tour needs to be cancelled by December 31, 2025 due to lack of registrations, initial deposits will be refunded in full.
  - b. Should the tour be cancelled due to reasons or events beyond the control of Scopia LLC (force majeure): Scopia LLC will work with tour suppliers for possible reimbursement of payments made to the suppliers. Amounts received by Scopia LLC will be reimbursed to tour participants, less a fee of \$300 per person to cover time and expenses by Scopia LLC.
- G. Important note: Payment and refund schedule and/or amounts may change if certain suppliers require deposits (refundable or non-refundable) which are not listed above.**
