What's happening at the State House?

Legislature is in full swing, with legislators taking action on bills, hearing testimony, and holding public hearings. The Legislature has set March 12, 2023 as the date for crossover this year.

What is crossover and why is it important?

Crossover is a deadline for bills that need to be voted out of committee in one chamber to be sent to the other chamber. Bills that are not voted out of a particular chamber by the crossover deadline will not see further action this year. If there is a particular bill you are interested in or following, you can reach out to your legislators directly by phone, email, or by visiting them at the State House. Your input may be important in helping to determine the outcome of a bill.

HOUSING COORDINATOR JOB DESCRIPTION

The Community Restorative Justice Center, Inc. (CRJC) of Saint Johnsbury is recruiting for a full-time Housing Coordinator. The person in this position works with our Transitional Housing Program supporting individuals referred from probation and parole. Specific responsibilities include the following:

- · Accept referrals for transitional housing and Navigation from the Department of Corrections;
- Update data in OMS weekly;
- Complete DOC quarterly report and send to Ex. Director;
- Facilitate all intake interviews and conduct needs assessments both in correctional facilities and at the CRJC;
- · Assist participants to prioritize their needs and goals and complete service plans;
- Attend all required DOC training;
- Facilitate house meetings and submit notes to Director and DOC Staff as needed;
- · Support participants in maintaining successful program participation;
- Maintain valid driver's license and insurance;
- · Work with Ex. Director to manage and report budget;
- Assure that all transitional residences are appropriately furnished and supplied;
- Maintain regular contact with landlords;
- Coordinate navigation services as needed;
- · Offer circles for conflict resolution for housing participants as needed.

This full-time (40hrs/week) position requires a flexible schedule that might include some evening/weekend hours. Training, education, course work and/or lived experience in the areas of substance abuse, mental health, trauma, poverty, and other related issues is desirable. The ideal candidate will be passionate about issues of social/racial/economic justice and restorative approaches to crime and conflict. Strong computer, data tracking, communication and phone skills are desired.

Additional Requirements:

- · Bachelor's degree in human services related fields;
- Trained in and supportive of the principles and practices of restorative justice;
- Proficient in verbal and written language skills and be able to communicate with others in person, via telephone, and by written correspondence, video conferencing, and email;
- Organized, self-actuating, dependable and trustworthy;
- Sensitive to the need for confidentiality and able to determine how and when confidentiality must be maintained;
- A team player willing to assist in general operations of the CRJC, including answering telephones, greeting the public, scheduling appointments, etc.
- Attend weekly staff meetings;
- · Facilitate or assist with mediation and group conferencing as needed;
- Willing to learn and step into other CRJC positions when needed.

The Community Restorative Justice Center, Inc is a 501(c)3 Nonprofit that strives to provide a link between city and town governments, law enforcement agencies and officers, schools, and citizens and neighborhoods to address issues of conflict and crime. NEKCA'S Volunteer Income Tax Assistance (VITA) program is a volunteer-based program which provides Vermont residents of Caledonia, Essex, and Orleans counties with free state and federal tax preparation services for individuals who meet the eligibility guidelines. The program services are available from February 1st to April 15th.

Who is eligible?

Vermont residents of Caledonia, Essex, and/or Orleans counties who meet at least one of the following eligibility requirements:

- Individuals who make less than \$58,000 per year
- Persons with disabilities; and/or
- Limited English-speaking taxpayers

We promote the principles of victim-informed restorative justice that transforms practices in workplace, school, institution, and living spaces throughout Caledonia and southern Essex Counties.

The CRJC is committed to providing a safe environment for resolving conflicts and to promoting restorative justice and victim sensitivity throughout the entire community, based on the following principles:

- Crimes and disputes are best resolved in the local communities where they occur.
- The victim has special needs and claims that are at the center of the resolution process.
- The offender has an opportunity to understand the impact of the crime, express remorse and repair the harm done to the victim and to the wider community.
- Community members have a right to feel safe, respected and involved in the issues that affect their quality of life and sense of personal well being.
