- One day of functional fitness
- 16-18 participants per day Working on reviewing waitlist.

Montfort Renaissance - Guillaume Gervais: •

French Program

- · Capacity to accept referrals.
- 4 days per week (Mon, Tues, Thurs, and Fri) 12 spots per day
- Referrals are slow coming in
- Many clients who are contacted not ready to start program.

WOCRC – Emily Moses:

- 2 sites: Algonquin and Kanata
- Programs Monday to Friday with a couple of evening sessions.
- Evening programs (Tues & Wed. 3 pm 8 pm)
- Virtual program: exercise and games
- Waitlist increasing
- Caregiver Support Group operating on Wednesdays.
- Questions about accommodating smokers in program- OWCS accepts smokers, Perley, requires written consent, Olde Forge, staff or volunteer take smoker out.

EORC – Julia Fatuma:

- Aline Vlasceneau is the CSS Coordinator
- 5 days per week

- Some capacity.
- Tues & Thurs French (Frail Elderly)
- 6-7 people waiting
- Caregiver Support Group operating.
- 0 Waitlist

Carleton Lodge – Sylvia Nicol:

- 9 clients per day (Mon to Fri) Carleton Club
- Dementia Program (17 people) including Tuesday & Thursday evenings, every Saturday full
- 33 people on waitlist

Abbotsford - Cassandra Ford:

- 3 davs per week
- 12 participants per day (one half day with 8 participants)
- 59 people on waitlist.

Olde Forge – Scott Roscoe:

- Mon (dementia programming)
- Tues (mixed programming)
- 12 people per day
- 100 on waitlist
- Virtual programming, numbers decreasing.

J.W. MacIntosh – Sarah Speer:

- 3 days per week (restarted the third day in November)
- Seeking a volunteer to assist.
- Transportation remains a challenge.
- M&W full, Friday 2 spots remaining

ROSSS – Lyn Rorke:

- Thursdays changed location to Kenmore, a rural location.
- Clients waiting due to transportation challenges.
- Tuesday in Manotick, joint programming with Caregivers.
- NROC (Nepean, Rideau, Osgoode Community Centre) providing Mental Health supports.
- Receiving many referrals without sufficient information regarding client

Hospice Care – Kayla Savoie:

- Undergoing staffing changes
- Capacity for referrals
- French Program seeking a new location. Program on hold while waiting for new building to open
- Caregivers Group in Kanata.

HCCSS – Isabelle Meunier:

- Changing name by the Fall to Ontario Health at Home
- Standardizing to align with the Provincial changes
- Asked about multiple day attendance and waiting list when clients go on vacation
- Discussion was held

Harmer House - Jenna Redman:

- Register 15 17 people per day
- 5 days a week.
- Waitlist decreasing
- Transportation is still a challenge.

The Good Companions – Penny Bodnoff:

- Staff at full complement, including a student.
- 5 days per week
- Often reach capacity, but then someone moves on, creating more space.
- Space on Fridays
- LGBTQ2+ programming; space available on Saturdays.
- Referrals welcome
