#### 5. Use of Technology to streamline MOW services

Several MOW Providers commented on their use of Alyacare for their client information systems and scheduling usage. While agencies are at different stages of implementing the Alyacare platform, all consistently stressed the importance of cleaning up 'old data' before transferring things over to this system, to enable data to be as current and accurate as possible. Those further ahead with the use of Alyacare, indicated while it is indeed a learning curve to adopt any new system, it is very helpful once integrated into agency practices.

It was suggested that perhaps, once some of our MOW Providers are further along with the adoption of this platform, we could arrange a presentation at a future MOW meeting (utilize the experience of early adopters within our network).
