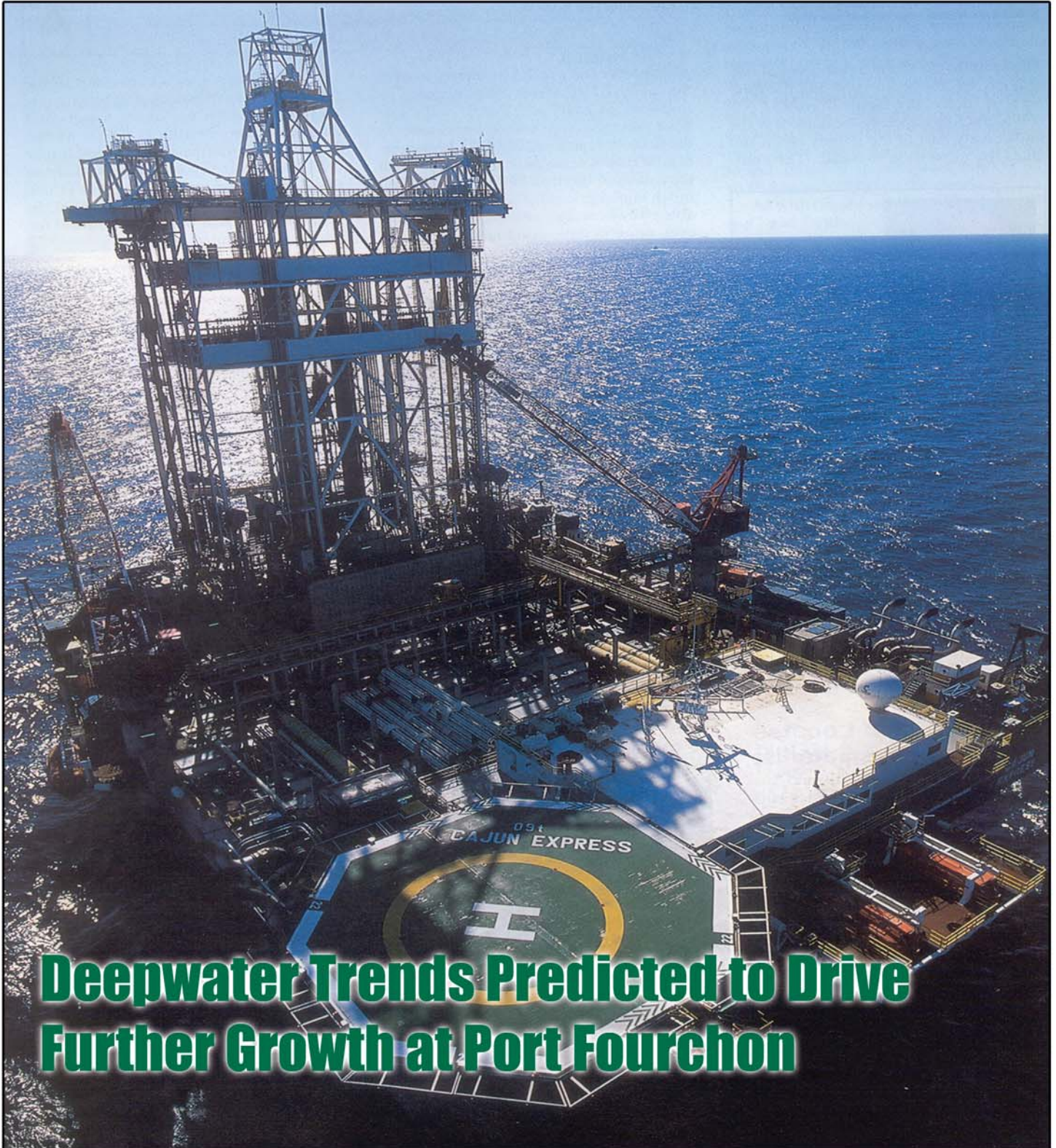

Mission

The Greater Lafourche Port Commission, a political subdivision of the state of Louisiana, facilitates the economic growth of the communities in which it operates by maximizing the flow of trade and commerce. We do this to grow our economy and preserve our environment and heritage.

Location

Port Fourchon, Louisiana's southern most Port, is located at the mouth of Bayou Lafourche in Lafourche Parish. Road access to Port Fourchon is via LA 1 and LA 3090. Also located just 30 miles from Port Fourchon is the South Lafourche Leonard Miller, Jr. Airport on Airport Road off of Highway 308 in Galliano, LA.

Overview

The Greater Lafourche Port Commission was established by the state of Louisiana in 1960 and exercises jurisdiction over an area of Lafourche Parish, south of the Intracoastal Waterway, including Port Fourchon and the South Lafourche Leonard Miller, Jr. Airport.

The Commission has targeted Port Fourchon for growth and development of Port facilities because of its ideal geographic location on the Gulf Coast. Fourchon's primary service market is domestic deep-water oil and gas exploration, drilling, and production in the Gulf of Mexico. Fourchon is comprised of 800 developed acres that house state of the art service facilities and is in the midst of its Northern Expansion project, which will double the port's size and will further accommodate the industry's growing needs.

In addition to developing Fourchon, the Commission has expanded the services of the South Lafourche Leonard Miller, Jr. Airport since acquiring it in 2002. This general aviation airport sits on 359 acres in Galliano, Louisiana and is surrounded by 1,200 acres of commission-owned property slated for industrial development. Its close proximity to Fourchon makes it the airport of choice for both business and recreational travel to South Louisiana. The airport is under aggressive expansion as well, with plans for a 6,500-foot runway with a full parallel taxiway to accommodate large jet aircraft.

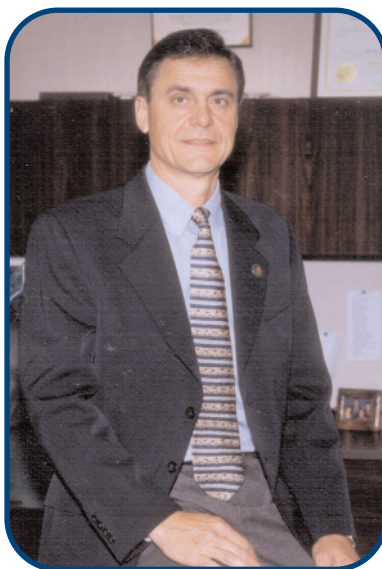

Deepwater Trends Predicted to Drive Further Growth at Port Fourchon

The importance of the deepwater extension of the Lower Tertiary trend is the significant increase in oil and gas reserves it will provide for decades to come. Lower Tertiary trend could boost the U.S. oil and gas reserves as much as 50 percent, holding up to 15 billion barrels of oil and natural gas liquids. Discoveries in the Gulf of Mexico Lower Tertiary have been at variable depths, wells drilled as shallow as 15,000 feet in some areas and as deep as 30,000 feet in others.

In the Gulf of Mexico newsletter, October 16, 2006 edition, it was stated that "the outlook for 2007 indicate a continued steady increase in production." One of the main market drivers of this increase is the startup of new deepwater developments.



Jack Well Test

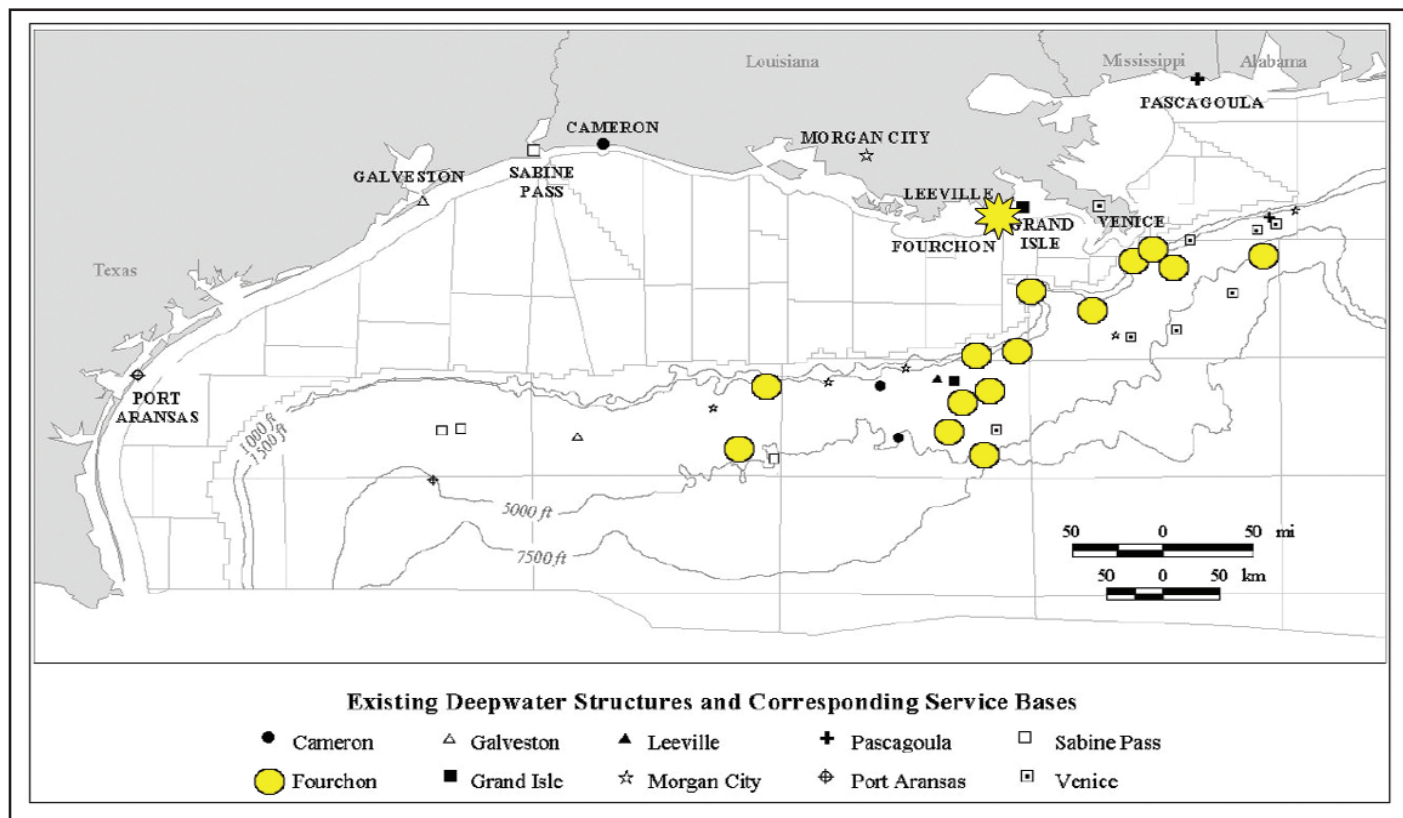
For years, Minerals Management Service (MMS) has emphasized this area as an area of "huge potential" of the deepwater zone.

Chevron announced recently that it successfully completed a record setting production test on the Jack #2 well at Walker Ridge Block 758 in the Gulf of Mexico. Jack #2 delineation well, located 175 miles from the Louisiana coast, was drilled to more than 20,000 feet beneath the sea floor in 7,000 feet of water. The well sustained flow rates of more than 6,000 barrels of oil per day. Chevron is the operator with a 50 percent working interest with Devon and Statoil each owning 25 percent working interest.

The Jack #2 well, the largest U.S. oil discovery in the deepwater Gulf of Mexico, is being serviced out of Port Fourchon along with the Jack #1. A third Jack well is scheduled for 2007. First production is not expected to come on line until after 2010, but the long-term ramifications of the discovery could be even more exhilarating for Gulf operators.

The Jack #2 discovery is speculated to be bigger than Alaska's Prudhoe Bay. Donald Vizier, Commission President said, "This discovery has great significance to this nation, and further accentuates the importance of Coastal Louisiana and the need for funding to address coastal infrastructure and land loss issues."

Lafourche Parish President Charlotte Randolph said the discovery is good news for this community, state and nation. "It will sustain the economy of this area well into the future and provide this country with much needed domestic energy," said Randolph.

Ted Falgout, Port Director said, "It is hard to quantify at this time what the Jack and others to come are going to mean, but one thing is for certain, without a substantial financial commitment from the federal government, it will be very difficult for landside support communities to meet the demands that will be placed upon them to fuel this nation."

Economist Loren Scott said that he is very optimistic about this area of the state due to what he calls the "Jack effect". Scott said, "The discovery will help add about 3,800 local jobs over the next two years, a solid growth rate of about 2.2 percent annually."

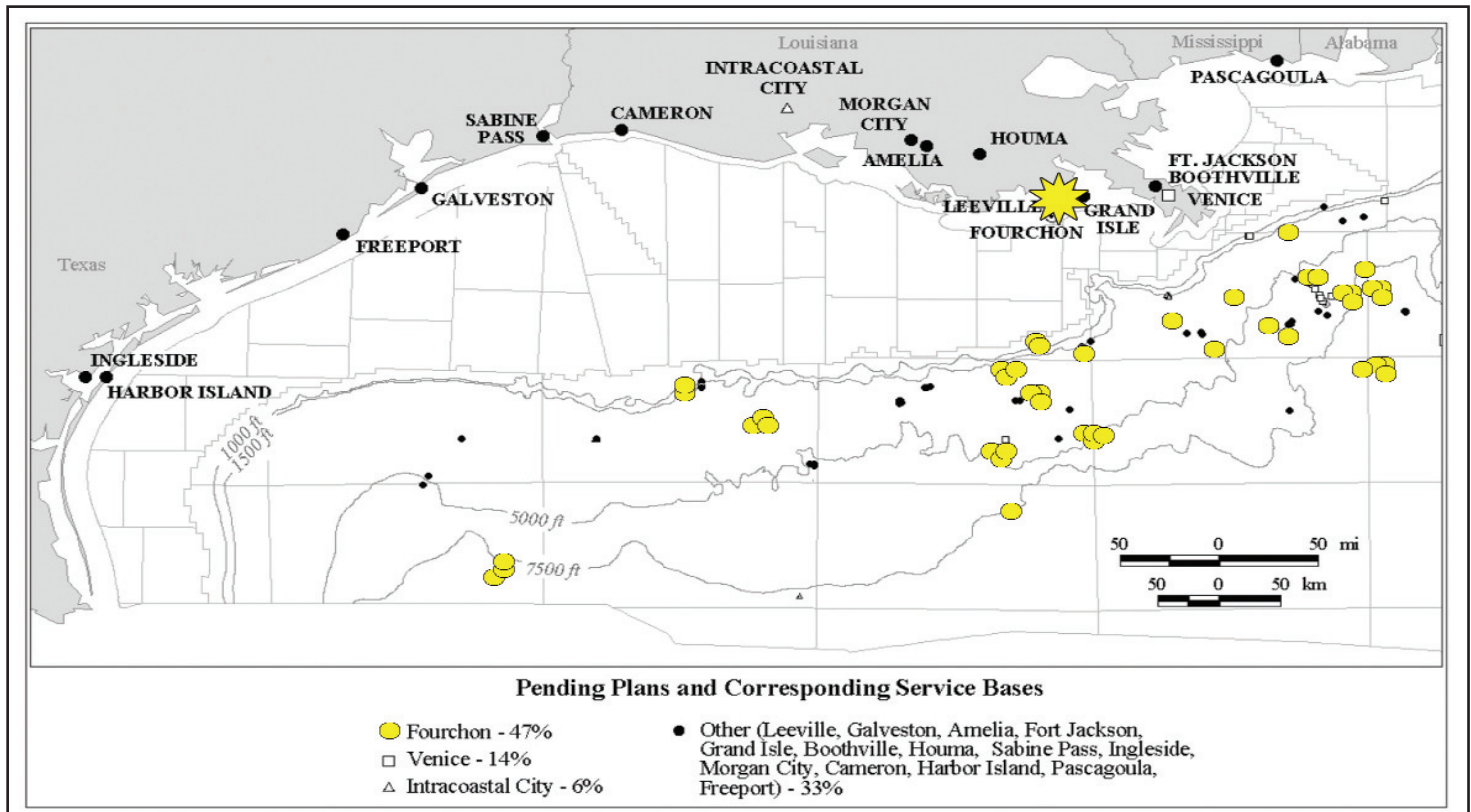
That rate would make Lafourche-Terrebonne the second-fastest-growing of the eight metropolitan areas in the state behind the Lafayette area, which is expected to have a growth rate of better than 2.4 percent.

The Jack deepwater discovery is one of several major discoveries that will be serviced out of Port Fourchon. Chevron is currently developing the \$3.5 billion Tahiti project located in Green Canyon Block 640. "Chevron is deploying the spar platform for the Tahiti in the summer, and the project will be supported out of Port Fourchon," said Matthew Carmichael from Chevron.

Port Revenues Meet and Exceed Strategic Plan Goals

In 2004, the Commission decided to conduct formal strategic planning. The goal was to look at where the port was, where it wanted to be, and how best to get there. With little previous formal strategic planning, the base line measurements from 2003 seemed to be a good starting point on which to base our goals. In fact, to get to those base levels, past performance had to be good. Consequently, the performance bar was set high with the future end of the bar pointing upward.

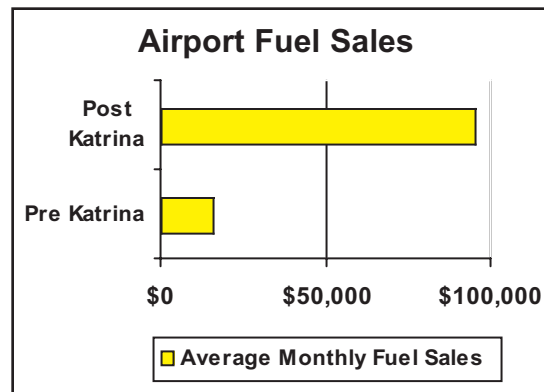
Some of the key monetary measurements included grants, operating revenues, net operating margin, departmental expenses, and airport operating cash flow. Some key non-monetary measures included number of companies under lease and number of employees. The chart below depicts these past, present, and future measurements since the strategic plan was developed.

Several of the measurement goals targeted to be obtained by 2009 have already been obtained and/or maintained such as grant income, net operating margin, companies under lease and employees (highlighted in blue in the below chart).

Operating revenue is projected to exceed the goal in 2007, two years early. Department expenses along with airport operating cash flow still have some improvements to be made by 2009, but both are obtainable (highlighted in red below).

The effects of Hurricane Katrina and Rita on the financial revenues of the commission have actually been favorable. Fuel sales at the airport are five times greater than they were before the storms as shown in the chart on the right.

No company left or relocated from Fourchon after the storms. In fact, severe impacts to ports in Venice and Cameron have led to many inquiries by potential tenants and have definitely added to the surge in development of the Northern Expansion Project.

Highlights from the 2005 Audit

Highlights presented in the 2005 Audit Report include:

- Net Assets equaled \$87.7 million which was a 22% increase over 2004
- Annual Operating Revenues equaled \$11.6 million which was a 12% increase over 2004
- Cash and Cash Equivalents equaled \$12.6 million which was a 12% increase over 2004
- Operating Profits equaled \$4 million which was a 32% increase over 2004
- Capital Grants equaled \$9.5 million
- Non-Capital Grants equaled \$818,000

The 2005 port operations were funded 49% by self generated fees, 39% by capital grants, 7% by ad valorem taxes, 3% by non-capital grants and 2% by other sources.

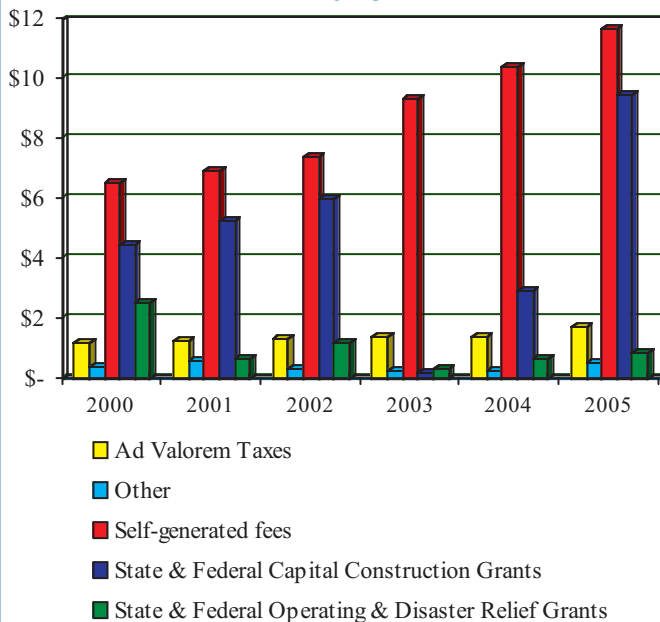
The chart on the bottom left shows six year trends in the commission's funding sources with consistent favorable growth in both self generated fees and ad valorem taxes.

The chart on the bottom right depicts the amount of capital construction the commission has expended from self generated profits over the last six years. Although capital construction is highly correlated to the amount of available federal and state grants that are available, the Port Commission has reinvested an average of over \$3.3 million per year back into capital construction.

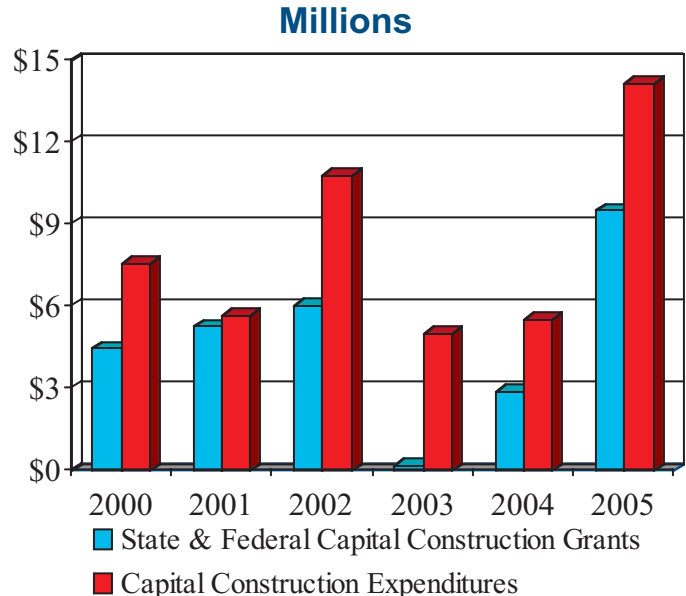
Johnny Melancon, Treasurer and Chair of the Finance Committee said, "The Port is in sound financial shape, and with new expansion coming in 2007, the Port should experience record revenues."

Mark Felger, partner with the CPA firm Lanaux and Felger, issued an "unqualified opinion" which is the best opinion that can be issued on the commission's 2005 internal controls and financial statements.

Millions**

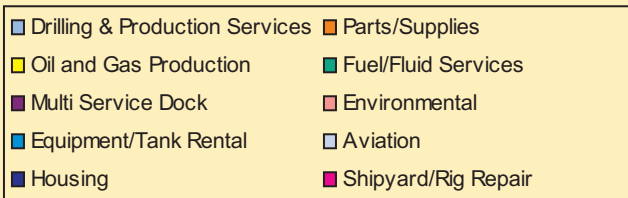
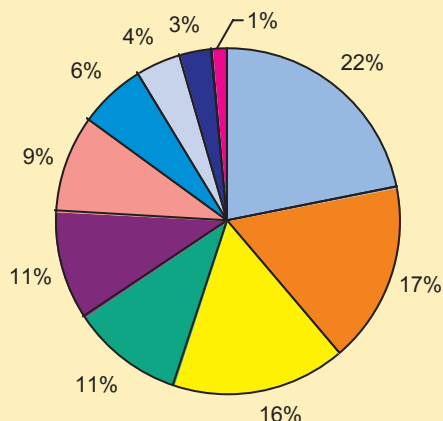


**Capital Grants and Construction

About the Port

Seaport Tenants by Industry



Port Fourchon’s ideal geographic location on the gulf coast is the foremost incentive for companies to service its primary market - deepwater oil and gas production and exploration.

Over 250 companies utilize the Port. From drilling and production to aviation companies, the Port serves as a “one stop shop” to this growing industry.

The chart to the left substantiates that Port Fourchon functions as a service base for the oil and gas industry. The diversity of companies located in the Port all work for the common goal of supporting the Gulf of Mexico production.

Port tenants provide logistics support, drilling fluids, food services, parts and supplies, helicopter transportation, etc. Many of these service providers have chosen to establish a base at Fourchon mainly because of the port’s close proximity to the the drilling activity in the Gulf.

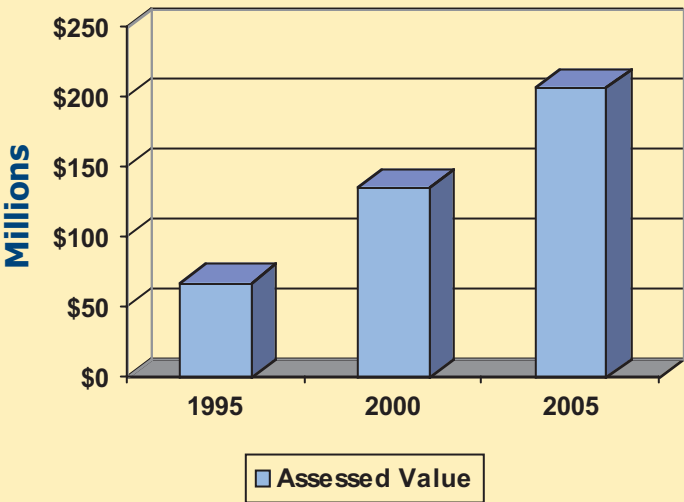
Port Fourchon houses state of the art facilities unlike any other in the world. Continued technology enhancements and long range strategic planning of port facilities have enabled Port users to meet the needs of oil and gas drillers, producers, and operators, all while saving time and money.

In 1961, the voters of the 10th ward approved a tax millage to fund development of the Port. In 2006, the Port Commission collected a 6.94 mills.

Funds generated from millages support roads, levees, water districts, libraries, veterans, special education, drainage, hospitals, schools, law enforcement, parish council, and fire districts to name a few.

The chart to the right shows the assessed value of property taxes in Port Fourchon over a ten year period. From 1995-2000 the assessed value of the Port increased by 100%. From 2000-2005, the assessed value increased by 52%. Properties are reappraised every 4 years, and the 2004 reappraisal accounts for 11% of the increase in property value in the Port between 2000-2005. The remaining 41% increase from 2000-2005 is due to the vast amount of new construction and on-site improvements to existing facilities in Port Fourchon to meet the demand of the industry.

Tonnage Statistics Indicate Increase Production at Port

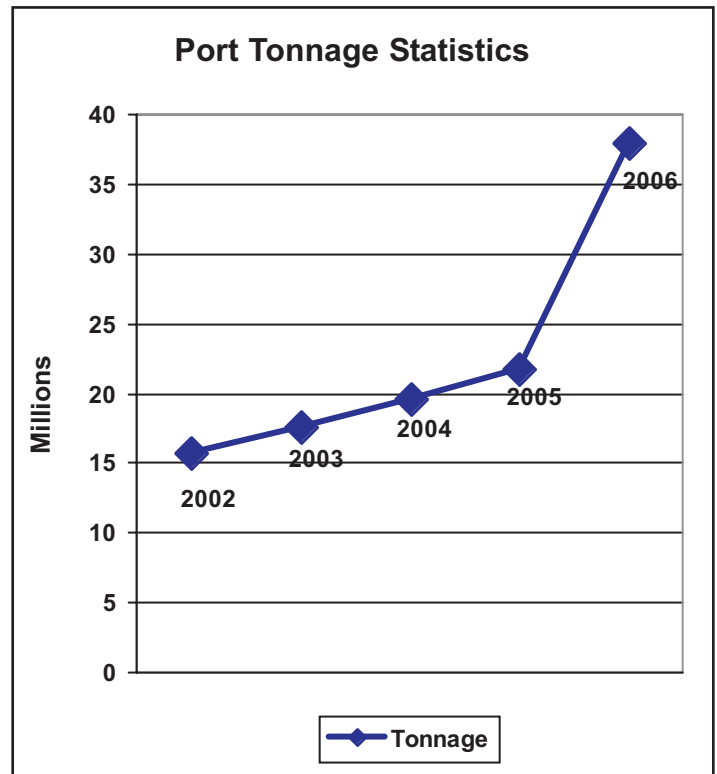
The overwhelming majority, over 95%, of tonnage handled at the Port is oil and gas related. Every widget and gadget needed to support the oil and gas industry is handled as cargo. It moves through container, bulk, breakbulk and just about every method imaginable.

Approximately 30% of total tonnage travels to and from the Port by inland barge before being transferred to or from an offshore supply vessel, and 70% travels to and from the Port by vehicle before being transferred to or from an offshore supply vessel or helicopter. The commodities commonly barged are the liquid bulk commodities such as oilfield fluids, heavy waters (CaCl₂), cement, and fuel.

Most other commodities are moved to and from the Port via vehicle. The most common vehicular transported cargoes include machinery, pipe, personnel, dry bulk, food, garbage, and specialty tools. Recent truck traffic studies have shown that over 1,200 trucks per day travel in and out of Port Fourchon. Inland barge traffic through Bayou Lafourche, the main barge route to the Port, has experienced paralleled increase with truck traffic.

It is difficult to measure the significance of Port Fourchon by a single standard such as tons of cargo, barrels of oil, worth of seafood, or number of recreational users. No all-encompassing method exists to measure Fourchon's activity against the more traditional port.

While the types of cargo handled in Port Fourchon have not varied widely over the last five years, the volume of tonnage transferred at the Port has increased with the rapid expansion of the Port. Cargo transferred by tenants has steadily increased each year by 12% from 2002 to 2005. It is estimated that in 2006, tonnage will increase 74% from 2005.



"The dramatic increase of cargo coming in and out of this port in the last year is a sound indicator of the Port's increasing role in the deepwater Gulf and in the hurricane recovery effort," said Jimmy Lafont, Commission Vice President.



LA 1 Coalition Humble Beginning Produces Impressive Effort

Ten years ago the President of the Greater Lafourche Port Commission gathered five corporate leaders in a board room to garner support for improvements to the vulnerable Louisiana Highway 1. Late president Tommy Doucet's forward thinking led to the group pledging annual support to an organization they would form known as the LA 1 Coalition. The stated goal of this coalition would be to improve the highway system between US Highway 90 and Grand Isle.

Immediately, the coalition successfully applied for 501(C)4 tax status, allowing it to lobby government bodies on both the state and national level for highway funds. With some funding in hand, the LA 1 Coalition hired an Executive Director, and the hard work began.

The first item of business was to document the need for a highway that was not on any government priority list and to educate local, state, and national officials of the energy significance that this corridor to the Gulf was going to assume into the future. Through the efforts of many, the project steadily gained clout.

By Executive Order, Governor Foster created the LA1 Task Force, whose report further documented and legitimized the effort. The Coalition worked closely with the U.S. Minerals Management Service (MMS) to document impacts and project future demand for this corridor.

MMS stated, "The ability of LA 1 to provide adequate level of services needed to support expanding offshore oil-and-gas activities will become increasingly strained." The study also suggests that deterioration of LA 1 will also be exacerbated with expanding oil and gas activities.

Funding for the LA1 project began to trickle in, and over \$7 million was appropriated in a major highway bill with monies coming from the allocation to Congressman Tauzin and Senators Breaux and Landrieu. This money required a 20% non-federal match.

Starting the environmental process was the next step. Oil and gas stakeholders raised the \$200,000 needed to match the federal contribution for the Environmental Impact Study (EIS) to begin. Unheard of before, the coalition brought all environmental partners to the table, and in record time, achieved a Record of Decision in only three years, half the amount of time that projects of similar magnitude have taken.

The Task Force report, Record of Decision, and several other major advancements crafted by a very dedicated state legislative delegation, including getting the project in the state plan, gradually brought the state in as a major player in the LA1 effort.



Realizing that highway construction through a remote wetland area would be very expensive, the coalition began to focus on funding sources. The leadership seized an opportunity to have a Toll Road Study performed, realizing that toll revenue could be key in jump-starting the project and attracting matching funds from government sources. By the year 2003, both studies were complete.

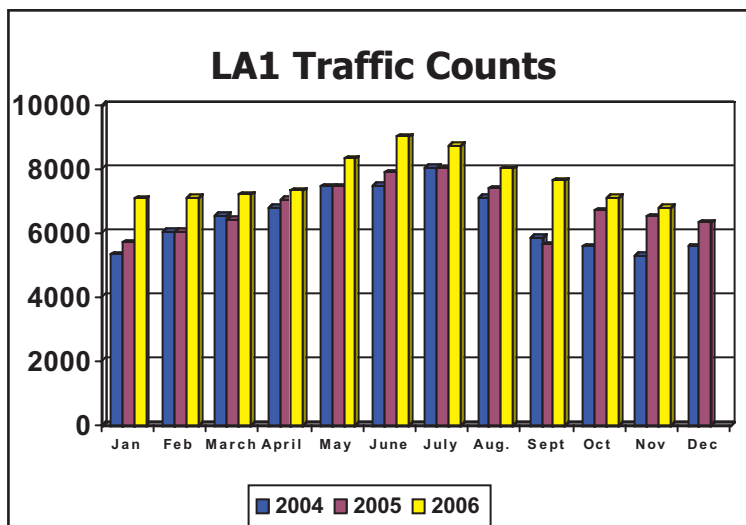

grant of \$1.7 million. Other years found annual appropriations from the U.S Congress ranging from \$1-3 million, and a greater level of support on 5-year long term transportation bills. By 2003 Congress had designated LA 1 a "High Priority Corridor"; however, no extra large appropriations for a new highway came with it.

Lobbying efforts for highway construction funds had been ongoing. With the Louisiana DOTD making the project a high priority, millions would be needed for pre-construction expenses such as design, engineering, and right-of-way acquisition. Additionally, federal and state funds arrived in 1997 with a Coastal Impact Assistance Program (CIAP)

Funding in 2005 brought optimism for actual construction. Bonds totaling \$96 million were sold on Wall Street to finance the Phase 1 segment of the new highway. Additionally Louisiana secured its first ever Transportation Infrastructure Finance Innovative Act (TIFIA) loan from the Federal Highway Administration in the amount of \$66 million. Both the bonds and the loan would be paid back through the collection of 30 years of tolls on the new highway. In addition, the 2005 federal highway construction bill known as SAFETY-LU awarded the LA 1 Project \$60 million. Louisiana State Governor Kathleen Blanco committed an additional \$90 million to the project mid 2006.



Traffic Counts taken just south of Leesville shows the increase of activity at Port Fourchon since the hurricanes of 2005. As is evident when looking at the post hurricane months and comparing them to traffic in the same months last year, it shows a double digit increase in activity for those months with January 2006 being a whopping 24% higher than January 2005. This is a sound indicator of the increased role Port Fourchon has assumed after the storms.

With nearly twenty-five percent of the funding secured for the four-phased \$1.4 billion dollar LA 1 Project, construction began in March of 2006 on two lanes of a 4.4 mile Leesville Overpass set to replace the aging and highly scoured Leesville lift bridge. The bridge is expected to open in early 2009. In December 2006, construction bids on 6.8 miles of two-lane elevated highway from Leesville to Port Fourchon will be opened.

Considering the fact that the entire effort is less than 10 years old, the LA 1 Project is moving at a remarkably fast pace with an anticipated \$300 million of construction underway by summer of 2007. "Our business community put their resources and minds together to ensure the economic vitality of their community. It is now beginning to pay off. We have a long way to go, but we know it's attainable," says LA 1 Executive Director Henri Boulet.

Port's History Demonstrates 45 Years of Success

The Greater Lafourche Port Commission was established in 1960 by the State of Louisiana Legislature Act 222. In 1961, voters of the 10th ward, the area of Lafourche Parish south of the Intracoastal Waterway, approved a 5-mill property tax to fund development of Port Fourchon. The late Senator A.O. Rappelet created the Port to capture the banana trade that had indicated it was leaving New Orleans for a spot on the coast, but the banana trade relocated to Gulfport instead. The first dock built on cement

piers is still to this day called the "Banana Dock" and is where ASCO is located.

Between 1961 and 1972, there was lots of work to do. Property was acquired, an aggregate road was built, Belle Pass was dredged to allow deeper access for vessel traffic, and capital improvement projects begun. In 1971, the first Board of Commissioners was elected. The first board included Irvin Melancon, Jr., Nolty J. Theriot, Andrew Martin, Antoine (Tan) Estay, Tomey Doucet, Loyman Terrebonne, Anson Toups, Harrison Cheramie, Jr., and Adam "Ted" Gisclair.

The late 70s was a time for many "firsts" for the Port. In 1976, Louisiana Offshore Oil Port (LOOP), the first and only offshore oil port, leased land from the Port

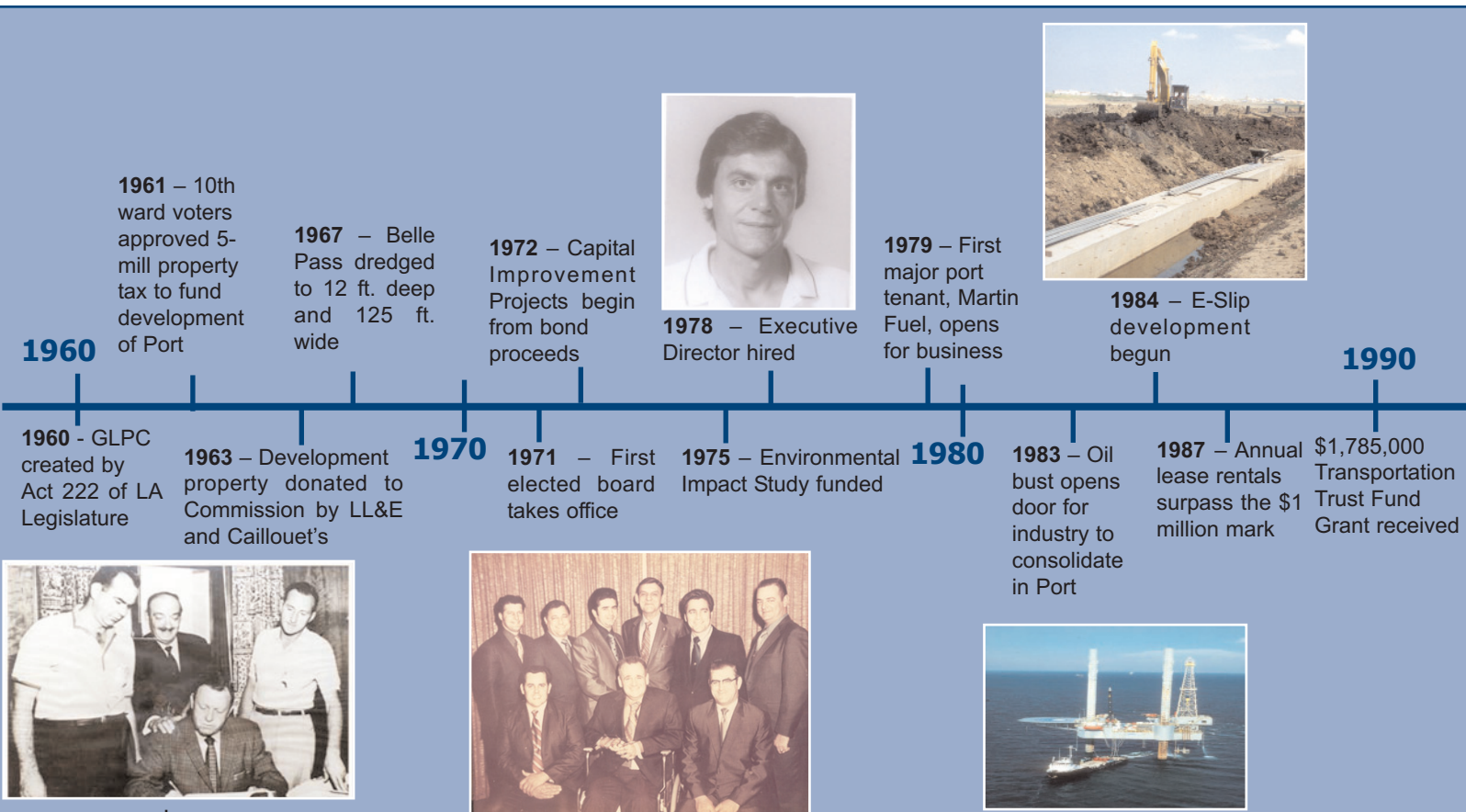
for onshore support and began operations in 1981. In 1978, the Commission hired their first and only executive director to date, Ted Falgout. In 1979, Martin Fuel, the first major port tenant, opened for business.

In 1984, construction on the E-slip development began. It was estimated that the first leg of the E-slip would take 10 years to lease and in 1994, it was completely leased. In 1993, the Commission began development of the second leg. It was estimated this leg would take until 2010 to lease, but it was totally leased in 1999, eleven years ahead of schedule. The Port then fast forwarded construction on the third leg of the E-slip which was estimated to be fully leased by 2030. The third leg was completely leased by 2000, and the Commission had not even begun to construct it.

This quick expansion was largely accredited to the passage of the Royalty Relief Act in 1995. The Act

implemented tax incentives that relieved eligible leases from paying royalties on defined amounts of deepwater production.

Vin Bruce, Chair of the Construction Committee for the Commission said, "The Royalty Relief tax incentives and new technological advances unleashed a new frontier in the oil and gas industry – the Deepwater Gulf of Mexico."

By 2001, the port had permitted the Northern Expansion project, a 700 acre expansion, and construction began. In only 5 years, construction on Slip A was complete and fully leased, and almost half of Slip B is constructed and leased.

As if developing a thriving port was not enough, in 2002, the Port Commission acquired the South Lafourche Leonard Miller, Jr. Airport. The airport was originally conceived in the early 1970s by interested citizens of Lafourche Parish who recog-

nized the importance air transportation and the role it would play in the future of economic development in Lafourche Parish.

The Commission recognized the importance of the Airport to support the continued development of Port Fourchon and the offshore mineral exploration and production. The Port Commission also acquired the 1,200 acres surrounding the airport and has slated it for industrial development of aviation-related businesses as well as companies in support of oil and gas activities.

Today, Port Fourchon plays a strategic role in furnishing this nation with 16-18% of its entire oil supply. Its location on the Gulf Coast makes it the shore base of choice for offshore oil support services. Nearly 250 companies operate and/or utilize Port Fourchon, and the Commission is responsible for a \$34 million budget.

Mineral Management Service (MMS) projects that the Port will service 47% of pending deepwater projects and no other Port is currently servicing more than 14%.

"The future of the Port looks bright because our niche, the deepwater Gulf of Mexico, is becoming even more active," said Commissioner Larry Griffin.

Port Security

Originated in 1972, Port Fourchon's Harbor Police Department began with only one Harbor Policeman, Mack Picou. Mr. Picou was the Port's first retiree and passed away in 2003. His

son, Paul Picou, following in his father's footsteps, now serves as a Harbor Police Patrol Officer.

The Port hired the first water patrol officer, Larry Terry, in 1986 primarily

to handle a bayou clean up project initiated by the Commission. "Back then, water patrol was not an impressive job of search and rescue that it is today. It was a dirty job of picking up trash in the bayou," said newly elected Commissioner and former water patrol officer, Jimmy Guidry.

Currently, Harbor Police has 10 full time Police Officers and 2 Water Patrol Officers. The Harbor Police department's main purpose is to enforce Port ordinances and to protect life and property. Over the years, Harbor Police officers have investigated theft, saved lives, made drug busts and arrested suspects for murder. Additionally, Harbor Police must act as environmental agents and are responsible for patrolling docks daily

to make sure vessels are not polluting the waterways.

Newly elected Commissioner Perry Gisclair added, "Harbor Police officers are not just security guards. They are highly trained professionals with a wide realm of responsibilities."

All the Harbor Police officers must go through Police Officer Standards Training. They are also required to pass yearly re-certification classes to keep up to date with changes in security. The officers are trained by U.S. Customs Service agents as well. U.S. Customs training allows them to work with federal officials to identify vessels and search vessels suspected of drug trafficking.

Dispatching is contracted through Fire District #3 located in Galliano. "Dispatching through Fire Central allows us to better communicate with other parish and state law enforcement agencies as well as ambulance and fire services in the event of an emergency," said Jon Callais, Director of Security.

In January 2007, Harbor Police will begin patrolling the South Lafourche Airport in Galliano as well. This has become necessary due to the continued fast pace growth of this facility.

Both Port Fourchon and the South Lafourche Airport are monitored with high tech surveillance cameras that record all activity going on at each facility. Harbor Police Officers are trained on these law enforcement tools which assist in deterring criminal activity.

Commissioner Wilbert Collins said, "Harbor Police has been an evolving department that performs a core function of keeping the Port safe and secure for its users."

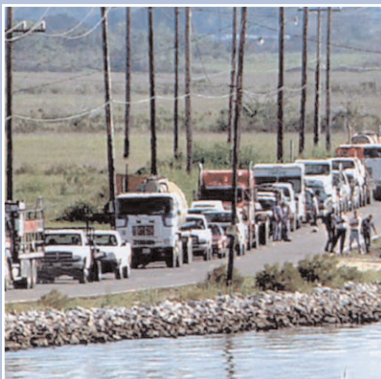

Northern Expansion Property in High Demand

The hurricanes of 2005 had an affect on Port Fourchon in many ways, and our construction projects were certainly not left out. It has taken longer than anticipated, but construction of 5,600 feet of waterfront in Slip B of the Northern Expansion has finally been completed. C-Terminal, Delmar, Expert Riser Solutions, Grand Isle Shipyard, Southern Tank Specialist, Express Weld, Intermoor, and US Liquids have taken advantage of Port Fourchon's expansion and assumed leases that encompass the entire 5,300 feet.



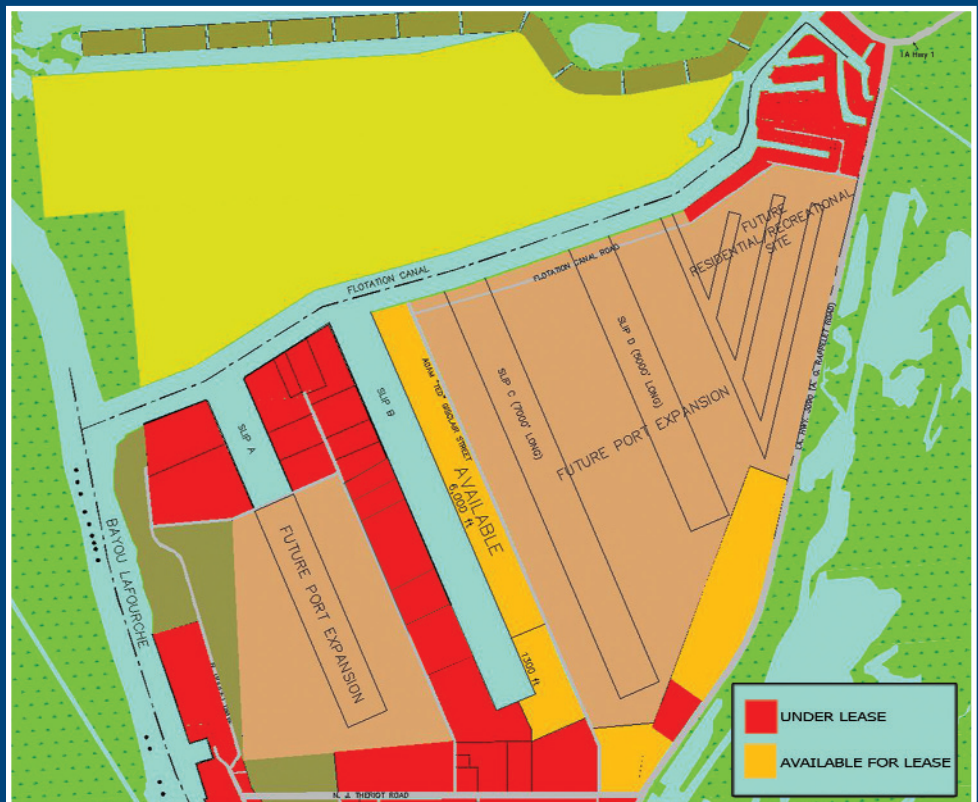
In early 2007, the Port Commission plans to begin construction on an additional 3,600 feet of bulkhead of which 1,400 feet has already been leased by Tiger Tanks, LLC. This bulkhead is expected to be complete in early 2008 and the remaining property is currently available for lease.

The Greater Lafourche Port Commission has initiated the process of obtaining permits to begin construction of Slip C in the Northern Expansion which will be 7,000 feet long like Slip B.

The Northern Expansion is 700 acres and will double the size of the Port.

- 5,600 feet of bulkheaded waterfront property will be complete at the end of 2006, with 100% already under lease.
- Another 3,600 feet of bulkheaded waterfront property will be under construction at the beginning of 2007 and is available for lease.
- Remaining 6,000 feet available upon demand.

Ridge Will Provide World Class Ecotourism & Storm Barrier for Port

In 2001, the Port put together a plan to rebuild a natural forest ridge that once existed just north of Port Fourchon which had fallen victim to coastal erosion. The re-creation of the Maritime Forest Ridge north of Port Fourchon mimics the natural ecology of the system and restores what was once a natural storm surge protection barrier. The ridge also re-establishes diversity to the area and will provide habitat for many species of plants and animals. In addition, it will ultimately provide world class ecotourism opportunities for the region.

Phase I, the center 3,000 feet of the project has been created, shaped, planted and is near completion. Phase II, the 3,000 foot section west of Phase I, has also been created and will be shaped and planted in 2007. Phase III, which will consist of over 6,000 feet and eventually stretch all the way to LA1, will be constructed from dredge material generated from future port expansions.

from the construction of 50 foot gaps in the ridge placed every 1,000 feet which was a requirement of the permit.

The Maritime Forest Ridge project, with Phases I and II partially constructed, proved the surge protection component of its concept works during the storms of 2005. Overall the ridge held up remarkably well and clearly acted as a barrier reducing some of the storm surge impacts to both the port mitigation area and facilities within the port.

To date, the Port has invested over \$2 million into the project. Much of this cost would have been incurred transporting the dredge material from creation of the Port slips to other locations had this beneficial project not been established.

Recently the Maritime Forest Ridge project has received national recognition. The Port Commission was the recipient of the American Association of Port Authorities' (AAPA) Environmental Enhancement Award and the 2006 Gulf of Mexico Program Gulf Guardian Award.

Ted Falgout, Port Director said, "While the Commission pursues its purpose of stimulating commercial development, it acknowledges the environmental value of the setting in which the Port is located by working hard to restore and protect the coastal landscape and habitats that surround it."

The port has been the cornerstone for much of this project, and has put together a diversified team of stakeholders, participating both financially and physically. Port Fourchon is working in conjunction with Barataria Terrebonne National Estuary Program, Gulf of Mexico Program, Gulf of Mexico Foundation, National Oceanic Atmospheric Administration, The Louisiana Department of Natural Resources, Shell, and the US Natural Resources Conservation Service's Plant Material Center.

The Maritime Forest Ridge (MFR) will ultimately stretch for approximately 12,750 linear feet, creating about 60 acres of marsh and 60 acres of ridge habitat. Ultimately, the project will include walking trails, bird identification stations and a coastal/marine ecosystem education center in addition to its role as a storm buffer. It is estimated that the total project will be completed by 2010.

Airport Provides a Vital Service to the Oil Industry

Recognizing the potential in providing air transportation services to support the continued development of Port Fourchon, the Port Commission acquired the South Lafourche Leonard J. Miller, Jr. Airport in Galliano, LA in 2002.

The Port Commission also acquired 1,200 acres surrounding the airport, and has slated it for industrial development of aviation-related businesses as well as companies in support of oil and gas activities ongoing at Port Fourchon. Businesses that have strong ties to the oil and gas industry but are not water-dependent could utilize this industrial park to establish their businesses in close proximity to the port, while remaining within the hurricane flood protection levee system.

Shortly after the acquisition, the Commission immediately began improving the facility. The initial improvements included installation of security measures, addition of fueling capabilities, re-surfacing of Airport Road, construction of an aircraft storage hangar, and installation of an Automated Weather Observation System (AWOS).

An Airport Master Plan was funded by the federal and state governments to provide a clear view of the facility's future and its potential contributions to the region. The Master Plan recommended extending the runway from 3,800 feet to 6,500, and widening the same from 75 feet to 100 feet. Additional improvements were recommended including strengthening the runway to support aircraft wheel loads up to 75,000 pounds, installation of airfield lighting and signage and navigational aids (NAVAIDS), as well as the construction of a full parallel taxiway.

The construction was broken down by Phases. Phase I and Phase II, which extended the runway from 3,800 feet to 6,500 feet, are complete. Phase III, scheduled to be complete by beginning of 2007 includes installing airfield lighting and electrical requirements. Phase IV will strengthen the runway to accommodate wheel loads up to 75,000 pounds and is scheduled for completion in early 2007.

Since the runway extension projects have been complete, the airport is now able to accommodate larger corporate jets. "In just the short while these improvements have been in place, we have had over 40 jet landings that could not land here before. Once the runway is strengthened to a weight of 75,000 pounds, the airport will be able to handle commercial type passenger and freight planes," said Jeffrey Hunter, Airport Manager.



Also, the Port Commission is currently in the planning and design stages for the construction of an instrument landing system (ILS), approach lighting system, safety area improvements, and full parallel taxiway. These projects are scheduled to be complete by 2010.

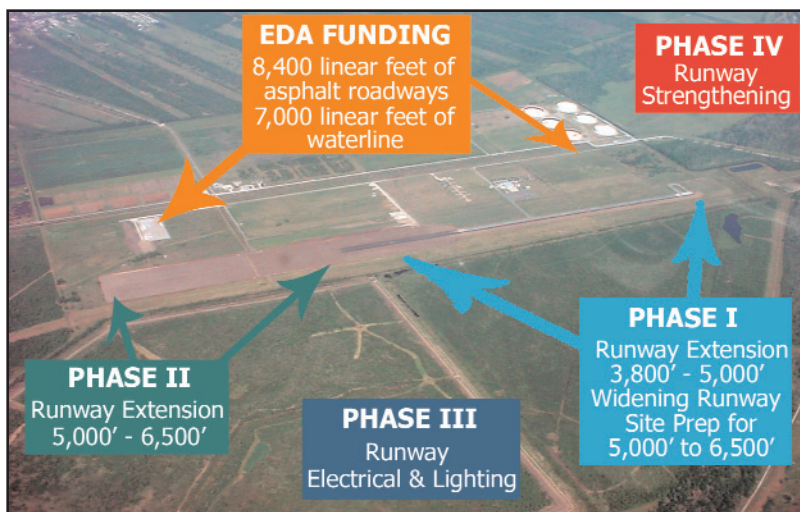
Recently, the Port Commission received an \$800,000 grant from US Department of Commerce Economic Development Administration (EDA) to be used for constructing 8,400 linear feet of asphalt roadways and placing 7,000 linear feet of waterline on the airport property.

The economic area surrounding the South Lafourche Airport is growing and changing dramatically. The increased demand for corporate related activity will prove to be a critical factor in the intermediate and long-term future of the airport. Companies in Fourchon have already identified the need for adequate air services in close proximity to Fourchon to transport specialized equipment in just-in-time fashion. The enhanced airfield capabilities will also help the public sector in times of natural disasters or national crisis.

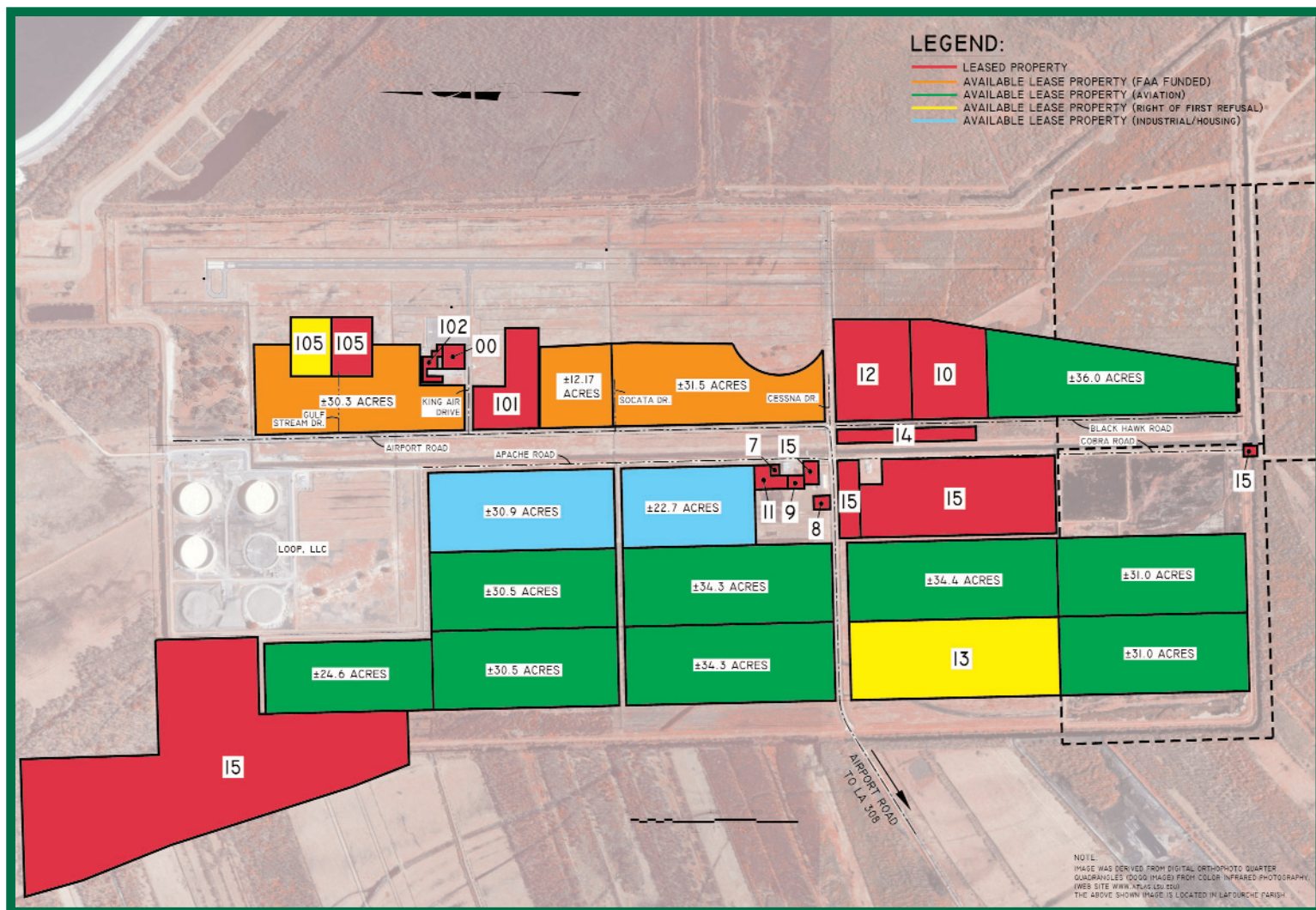
Commissioner Harry Cheramie said "The Commission is dedicated to helping lessees succeed, having created an environment that fosters development of their business and has superior infrastructure to support their operations."

The most significant factor in the future growth at the airport is related to the development of facilities.

"The Port Commission has made a strong commitment to change the airport's role from a small aircraft recreational facility into a premiere corporate facility. The airport should be a vital component in the matrix of transportation, service, and support facilities for the deepwater oil industry in the Gulf of Mexico," said Commissioner Beau Martin.
