• Failure to settle invoices within a 4 week period, will result in your nursery place being withdrawn and the deposit will be retained until invoices are settled or used against unpaid invoices.

TERMS AND CONDITIONS.

ABSENCES

Any absences will be charged at the normal rate.

HOLIDAYS

Each child is entitled to 2 weeks holiday a year without a charge, provided that at least 4 weeks notice is given in writing.

These 2 weeks free holiday may only be taken as whole weeks and not as odd days. They may also only be taken within that calendar year and may not be carried over to the next year.

Christmas week and Bank Holidays when Toybox is closed, are free and are in addition to the 2 free holiday weeks.

INVOICES

Invoices are issued weekly and are to be paid within 4 weeks. Failure to settle any invoices within 4 weeks will result in your child's nursery place being withdrawn with immediate effect.

SETTLING IN SESSIONS

To ensure every child is integrated into the nursery prior to their first day we will arrange settling in sessions for them with you. These sessions will increase in length and they can have as many as they need to ensure they are happy with us. These sessions are free of charge until they reach 4 hours long – they are then charged at our normal rates.

REGISTRATION FEE

A £45 registration fee is required. Children accessing <u>only</u> their EYFE hours are exempt from this charge.

RESERVATION DEPOSIT

Once a place has been confirmed at Toybox for your child, we will ask for a non refundable deposit to hold this place until your child starts. This deposit will vary depending on how many sessions you are reserving and will be returned when your child leaves and all outstanding invoices are settled. For children accessing only EYFE hours this will be returned once they start and after headcount.

NOTICE

4 weeks notice in writing is required should you wish to relinquish your child's place at Toybox.

CHANGES

4 weeks notice is required should you wish to alter your child's hours/days at Toybox. (Subject to availability)

DROP OFF & COLLECTION

Toybox's opening hours are 7.15am – 6pm.

In order to ensure we are always running at the correct Ofsted regulation staff/child ratios, Toybox asks that you drop off and pick up at the times you have pre booked.

Late collection charges will be applied.

In addition to the above Terms and Conditions, we ask all parents to abide by our Policies and Procedures. Failure to comply may result in your nursery place being withdrawn with immediate effect.
