The funeral goods and services shown are those we offer to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you select.

Payment for goods, professional services, and cash advancements is expected at time of arrangements and required prior to the services rendered. For your convenience we accept cash, check, and all major credit cards are accepted with a 3% merchant fee. Assignments on life insurance policies will be taken on a case by case basis.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

#### **CREMATION SERVICES**

### \$1450.00

Direct cremation is the disposition of the body by cremation, without embalming, no formal viewing or ceremony. Our charge includes:

The basic services of the funeral director and staff, transfer of the body from the place of death within Ventura & Santa Barbara Counties (Service Area) to our refrigerated holding facility and crematory facility, minimum preparation of the deceased, alternative cremation container used for cremation process, filing of the death certificate and necessary permits, the county disposition permit, assistance with filing for benefits through Social Security and Veterans Administration, refrigeration, the actual process of cremation and a plastic container for the cremated remains to be returned to the responsible party.

Cremation will take place within seven days of receiving a California Disposition Permit. Standard cremation is based on deceased being under 250 lbs.

You may want to arrange a direct cremation; you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard of composition materials (with or without an outside covering). The materials we provide are cardboard.

Average time for completion of services is 7-10 business days of receipt of proper authorizations. A rush service may be available for an additional fee. Consult your director for possible options.

Scattering services on a chartered boat and on a chartered airplane are available and vary in price. Also available, memorial urns, keepsakes and guest books. They are not included in the fees listed above.

## DIRECT BURIAL \$3995.00

Direct burial is disposition of the body without embalming, no formal viewing or ceremony.

Our charge includes:

The basic service of the funeral director and staff, transfer of the body from the place of death within Ventura & Santa Barbara Counties (Service Area) to our refrigerated holding facility, transportation to the cemetery for burial, minimum preparation of the deceased, grey cloth covered fiberboard casket, filing of the death certificate and necessary permits, ordering of "certified" death certificates from County Registrar, the county disposition permit, assistance with completing cemetery arrangements with cemetery staff, assistance with filing of Social Security notification form and Veteran's Administration forms.

B. Direct Burial (with Grey Cloth covered Fiberboard Casket) \$3995.00

Average time for completion of services is 7-10 Business days of proper authorizations.

A graveside Service with family and or friends present is available for an additional cost. Consult your director for possible options.

#### Basic Services of Funeral Director and Staff \$795.00

This fee for our basic services will be added to the total cost of funeral arrangements you select (This fee is already included in our charge for direct cremation). This fee includes but not limited to availability of staff 24 hours a day, 365 days a year to respond to your initial request for services. Minimum preparation of the deceased, arrangement conference with funeral director. Coordinating service plans with crematory and/or other parties involved in final disposition of the deceased. Filing of death certificate and obtaining permits with the County Health Department. Providing assistance in filing Social Security notification form and Veteran's Administration forms.
