SERVICE MEMBERSHIP AGREEMENT

1. Term of Agreement

This Agreement binds both parties to a standard one (1) year commitment (the "Initial Term") beginning on the Effective Date and expiring exactly twelve (12) months thereafter, unless terminated early in strict compliance with Section 7 of this Agreement.

2. Membership Tier Selection & Subscription Pricing

The Member elects to subscribe to the annual membership tier designated below (please check **one** plan and **one** corresponding payment option):

☐ **Standard Membership** — Guarantees two (2) half loads from our 22' x 6½' trailer per month.

☐ **Monthly:** \$99.00 / mo

☐ **Quarterly:** \$396.00 / qtr

☐ **Yearly:** \$1,000.00 / yr **(Save 10%)**

☐ **Premium Membership** — Guarantees four (4) half loads from our 22' x 6½' trailer per month.

☐ **Monthly:** \$198.00 / mo

☐ **Quarterly:** \$756.00 / qtr

☐ **Yearly:** \$2,042.00 / yr **(Save 10%)**

3. Payment Schedule & Methods

1. Payment Cycle: The initial subscription payment corresponding to the selected tier and frequency is due upon signing. Subsequent regular monthly, quarterly, or annual billings will commence exactly one cycle period from the date the initial payment is made and will recur on that same numeric calendar day each following billing period.

2. Accepted Methods: Payments must be made via Cash, Check, or Venmo. Cash or checks may be hand-delivered or mailed to the Company's business address: 3340 Cottonmill Avenue, Kearney, NE 68845. Checks must be made payable to Junk Wagon LLC.

3. Payment Reminders: As a courtesy, the Company will send automated text message reminders to the Member's designated mobile number a few days prior to each payment due date. Failure to receive a reminder does not waive the Member's obligation to remit payment on time.

4. Included Services (Monthly Allowance)

The monthly subscription fee explicitly covers the corresponding trailer load allocation (utilizing the Company's standard 22' x 6½' trailer dimensions) designated by the chosen tier in Section 2 per billing cycle. Unused half-load allocations do not roll over into subsequent months and expire automatically at the end of each billing period.

5. Additional Volume & Discounted Pricing

Any additional hauling volume requested by the Member exceeding their designated monthly tier allocation will be fulfilled and billed. These additional loads will be invoiced at the Company's standard regular price, minus an exclusive 10% membership discount.

6. Exclusions & Service Restrictions

Regardless of the selected tier, this membership is strictly for standard hauling and junk removal. The following items and services are **EXPLICITLY EXCLUDED** from the scope of this subscription and will not be accepted under any standard monthly allotment:

- Tire Removal (of any size, vehicle type, or quantity)
- Mattress & Box Spring Removal
- Demolition Services (including structural teardowns, interior gutting, or heavy debris breakdown)

Additionally, the Company strictly **reserves the right to refuse the collection, handling, and transportation of certain hazardous materials**, including but not limited to chemicals, flammable liquids, biohazards, or toxic substances.

**Note: Handling of excluded items or requests for demolition may be quoted independently under separate standard service invoices outside of this membership.*

7. Early Cancellation Policy

The Member retains the right to cancel this agreement prior to the completion of the one-year Term. However, if the Member elects to terminate the membership service before the full 12-month contract duration has expired, the Member agrees to pay an immediate, one-time Early Cancellation Fee of \$75.00. Membership privileges will cease immediately upon processing the cancellation and fee payment.

8. Governing Law & Acknowledgement

This contract shall be governed by and construed in accordance with local state laws. By signing below, both parties acknowledge that they have read, understood, and agree to be bound by all pricing structures, rules, and restrictions set forth in this document.
