Guarantor Requirements

The loan requires a personal warm body guaranty from all members with ownership of \geq 25% unless otherwise approved by the Credit team.

- 1. Individual or entity with ≥ 25% ownership
 - 1.1. Entity layers will require an Operating Agreement to determine beneficial interest in the borrowing entity
- 2. If a single individual does not own at least 25% of the borrowing entity, then a personal guaranty is required from individuals that own an aggregate of 25% or more in the borrowing entity
- 3. Bad Boy Carveouts and Corporate Recourse may be considered as an exception from the Truly Investor Capital Management Team
- 4. Non-Owner with direct control of the borrowing entity (Manager or Officer with Binding Authority) who are not Guarantors on the loan will generally require an OFAC and background check determined in Underwriting

Permitted: Trust, LLC, Partnership (LP, LLP, LLLP), and/or Corporation (C & S)

- Trust Borrowing entity Trust Borrowers will be allowed with the following requirements:
 - Inter-Vivos Revocable Trusts only
 - All Grantors and Trustees must be Guarantors
 - Irrevocable Trusts, Land Trusts, and/or Blind Trusts are not eligible

Not Permitted: Sole Proprietor, Retirement Plan (IRA/401k), General Partnerships, Cooperatives, Joint Ventures

Guaranty Types

Full Recourse Guaranty

Limited Recourse with Bad Boy Carveouts

- Also known as "Springing Recourse" provisions, triggers full personal liability for the borrower and/or guarantor if certain prohibited acts occur, including but not limited to:
 - Fraud or intentional misrepresentation
 - · Voluntary bankruptcy filings or insolvency actions without lender consent
 - Unauthorized transfers or liens on the property
 - Misappropriation or diversion of rents, insurance proceeds, or reserves
 - · Criminal conduct related to the loan or property
 - · Failure to maintain the required insurance

Corporate Guaranty

- Full Recourse The corporate guarantor is liable for the entire debt obligation, regardless of the value or disposition of the collateral
- Limited Recourse The guarantor's liability is restricted to certain conditions, amounts, or collateral, but may include bad boy carveouts that trigger full recourse upon specific prohibited acts
