

# Adult Tuition Plan

Regular lessons are provided by way of an ongoing tuition plan that delivers lessons at a discounted rate in a reserved regular slot.

The Adult Tuition Plan delivers 24 x 60 minute lessons over the course of each year in a reserved fortnightly slot. This tuition plan is designed for busy adults, allowing more time for practice between lessons whilst still providing the routine and regular contact essential for making good progress.

## Lesson Scheduling

- Fortnightly 60 minute lessons
- Reserved daytime & evening lesson slots Mon-Fri
- In-person lessons are available in the teaching studio
- Online lessons are available over Zoom

## Lesson Dates<sup>1</sup>

- 24 reserved lesson slots scheduled over the course of each year
- 48 teaching weeks available in total throughout each year

## Contract & Cancellations<sup>2</sup>

- Individual lessons can be deferred by providing 48 hours' advance notice
- Deferred lessons can be rescheduled to any available slot within the next 90 days
- A maximum of 2 deferred lessons can be accumulated at any one point in time
- Tuition can be discontinued at any time by providing 30 days' advance notice

# Terms & Conditions (Adult Tuition Plan)

## 1. Purpose

- (a) This document applies to all services delivered by The Guitar Coach to provide music tuition under the Adult Tuition Plan.
- (b) By entering into an agreement to receive tuition under the Adult Tuition Plan, The Student agrees to be bound by the terms and conditions described herein
- (c) For the avoidance of doubt, there is nothing that restricts a person of any age from receiving tuition under the Adult Tuition Plan.

## 2. Definitions

- (a) 'The Guitar Coach' refers to Justin Dowling trading as The Guitar Coach for the purpose of providing music tuition services.
- (b) 'Teaching Studio' refers to the location at which The Guitar Coach provides music tuition services (current address provided in 12(c)).
- (c) 'The Student' refers to the person named in the Student Details section of the Lesson Contract and, where different, includes the person named in the Signatory Details on the Lesson Contract.
- (d) 'Contract Offer' refers to an offer from The Guitar Coach to The Student to provide music tuition services.
- (e) 'Lesson Contract' refers to the completed Instrumental Lesson Contract or any other documentation submitted by The Student to The Guitar Coach that demonstrates a clear indication to accept the Contract Offer.
- (f) 'Adult Tuition Plan' is a marketing label that describes the terms and details of a specific agreement under which tuition is provided.
- (g) 'Academic Year' refers to a period of 12 calendar months that commences annually on 1st August.
- (h) 'Lesson Dates Document' refers to an annual calendar of dates on which lessons are to be scheduled for each Academic Year.
- (i) 'Deferred Lesson' refers to any scheduled lesson cancelled by The Student that is eligible for rescheduling at a later date.
- (j) 'Missed Lesson' refers to any scheduled lesson cancelled by The Student that is not eligible for rescheduling at a later date.

## 3. Lesson Scheduling

- (a) The Lesson Dates Document for the current Academic Year is issued to The Student together with the Contract Offer.
- (b) For subsequent Academic Years, the Lesson Dates Document is to be issued to The Student in advance by 31st May each year.
- (c) All lessons are to take place at the Teaching Studio unless otherwise agreed.
- (d) Each Academic Year includes 48 teaching weeks with four weeks of non-teaching holiday periods scheduled annually.
- (e) Lessons are scheduled on alternate teaching weeks in a reserved regularly scheduled slot for an agreed day and time.
- (f) A total of 24 lessons, each of 60 minutes duration, are to be scheduled over the course of each Academic Year.
- (g) An average of two lessons are to be scheduled each month, but the exact number will vary from month to month.

## 4. Tuition Fees

- (a) Tuition fees represent both the provision of tuition by The Guitar Coach and the reservation of a regularly scheduled lesson slot for an agreed day and time, at the request of and for the singular benefit of The Student.
- (b) The rate at which tuition fees are payable at the outset of the agreement are detailed in the Contract Offer.
- (c) Tuition fees are reviewed annually with any changes effective from the start of the new Academic Year. The Student shall receive advance notification of any impending changes to tuition fees no later than 31st May in advance of the start of each Academic Year.
- (d) Unless agreed otherwise, regular tuition fees are to be paid by a standing order payment on the 1st banking day of each month.
- (e) Each monthly standing order payment equates to exactly two lessons with the first payment of each Academic Year due 1st August.
- (f) The first and last payments due under the terms of this agreement will be adjusted if necessary to ensure that the total fees to be paid by The Student for that Academic Year correspond exactly with the number of lessons scheduled.
- (g) The Guitar Coach is not authorised by the Financial Conduct Authority to offer credit and any tuition fees paid by monthly standing order are not to be confused with an offer for The Guitar Coach to provide credit to The Student.

## 5. Cancellations and Absences

- (a) Where The Student is unable to attend any scheduled lesson and notice is received by The Guitar Coach more than 48 hours in advance of the scheduled lesson start time, it will be deemed a Deferred Lesson.
- (b) Where The Student fails to attend any scheduled lesson and notice has not been received by The Guitar Coach a minimum of 48 hours in advance of the scheduled lesson start time, it will be deemed a Missed Lesson.
- (c) In the event that physical injury ever temporarily precludes The Student from playing a musical instrument, The Student should still seek to attend lessons. Many lesson activities can be conducted without The Student needing to play a musical instrument.
- (d) In the event of snow or other extreme weather that prevents The Student from being able to attend any in-person lesson, the lesson will be conducted in an online setting using a video conferencing facility.
- (e) In the event that The Guitar Coach is unavailable to deliver any scheduled lesson, it will be rescheduled to a time mutually agreeable with The Student. If this is not possible, a refund will be issued at the current lesson fee.

**6. Punctuality**

- (a) The Guitar Coach cannot extend any lesson beyond the scheduled finish time to compensate in the event that The Student is not available, ready and prepared to commence the lesson at the scheduled time.
- (b) For in-person lessons, The Student is encouraged to arrive up to a maximum of five minutes prior to the scheduled start time for each lesson in order to be ready and prepared to start each lesson at the time agreed.
- (c) Where lessons are conducted in an online setting, The Student is encouraged to check all relevant settings immediately prior to each lesson to ensure that all necessary equipment and connections are operating to the satisfaction of The Student.

**7. Deferred Lessons**

- (a) Deferred Lessons can be rescheduled by The Student to take place during any available lesson slot for a period of 90 days following the date of the original lesson.
- (b) Deferred lessons cannot be rescheduled to take place at the time and in place of any regularly scheduled lesson for The Student.
- (c) Any Deferred Lesson that remains outstanding 90 days after the date of the original lesson will be deemed a Missed Lesson.
- (d) A maximum of two outstanding Deferred Lessons can be accumulated at any one time. In the event that The Student defers any lesson whilst two Deferred Lessons remain outstanding, the earliest of the three dates will instead be deemed a Missed Lesson.

**8. Missed Lessons**

- (a) The Guitar Coach is unable to reschedule or refund any lessons deemed to be Missed Lessons.
- (b) All Missed Lessons must be paid for in full at the current lesson fee.

**9. Cooling-Off Period**

- (a) The Student has a statutory right to cancel this contract without providing any reason during an initial Cooling-Off Period.
- (b) The Cooling-Off Period expires 14 days after the signed Lesson Contract is received by The Guitar Coach.
- (c) The Student can exercise the right to cancel the agreement during the Cooling-Off Period by providing written notice to The Guitar Coach using the contact information provided in 12(b).
- (d) In the event that The Student exercises the right to cancel the agreement during the Cooling-Off Period, The Student shall receive a pro rata refund for all monies paid in respect of the contract for which tuition has not yet been provided.

**10. Termination**

- (a) This agreement continues on an ongoing basis and has no fixed end date.
- (b) The Student can terminate this agreement by providing 30 days' written notice using the contact information provided in 12(b).
- (c) The Student remains liable to pay for all lessons previously scheduled under the terms of this agreement for the 30 day period following the date on which The Guitar Coach receives written notice of The Student's intention to discontinue tuition.

**11. Student Obligations**

The Student agrees:

- (a) to pay for the reasonable cost of any replacement strings required by The Student and provided by The Guitar Coach.
- (b) to be responsible for any loss or damage incurred to any equipment, instrument, accessory or music loaned by The Guitar Coach to The Student. Such items must be immediately returned upon request.
- (c) not to share or duplicate any educational resource of any kind that has been provided by The Guitar Coach. This includes but is not limited to any and all instructional material, notated music, chord charts, guitar tablature, fretboard diagrams, chord boxes and lyric sheets, and includes items provided in physical and digital formats including any files downloaded from [www.theguitarcoach.uk](http://www.theguitarcoach.uk) or shared through links to internet cloud storage or file-sharing platforms.
- (d) not to share, publish or broadcast in any way any audio or video content that has been provided by The Guitar Coach or recorded during lessons. The Guitar Coach retains the copyright to any recordings made during lessons, both those held in person and those conducted using Zoom, Skype, FaceTime or any other video conferencing facility.
- (e) to be responsible for the insurance of The Student's instrument.
- (f) to inform The Guitar Coach of any medical or other condition that may affect The Student's well-being during lessons.

**12. General**

- (a) The Guitar Coach reserves the right:
  - (ii) to withdraw tuition services at any time by providing written notice to The Student and issuing a pro rata refund for any monies paid for which tuition has not been provided.
  - (iii) to vary these Terms & Conditions at any time by providing The Student with 60 days' written notice in advance of any changes.
