TENNESSEE'S AVIATION HALL OF FAME

The Tennessee Aviation Hall of Fame was established to recognize, honor and enshrine individuals whose leadership in or for aviation/aerospace, whether by exceptional service or extraordinary achievement has made an enduring contribution to aviation/aerospace for Tennessee, our nation or the world.

Established in 2001 as Tennessee's Official Aviation Hall of Fame by the 102nd General Assembly, those honored are recipients of Tennessee's highest honor in aviation and aerospace. This institution will record these achievements or service and perpetuate the memory of those enshrined for all time.

The Tennessee Aviation Hall of Fame is located inside the Tennessee Museum of Aviation on the airport in Sevierville, Tennessee.

THE NOMINATION & SELECTION PROCESS:

Eligibility for induction into the Tennessee Aviation Hall of Fame is based entirely upon the nominee's significant and enduring accomplishments or service to aviation and/or aerospace for Tennessee, our nation, or the world.

Nominations are accepted any time. The Nominator may be requested to appear before the Board in support of this nomination. No campaigning, political intervention or attempts to influence any nomination will be accepted or considered and may potentially prejudice selection. The Nominee's qualifications stand alone in the selection process and are weighted favorably if achievement(s) or service were unique, enduring and especially significant.

The nominee's service or achievement must have been made from within Tennessee or by a Tennessean, living or deceased. *The nominee does not have to be a native born Tennessean if the nominee's service or achievement was made from within Tennessee.* The nominee must be a native born Tennessean if the nominee's service or achievement was made outside the borders of the State of Tennessee. The Tennessee Aviation Hall of Fame Board of Directors will select honorees once each year. Those chosen for induction will be enshrined at a formal ceremony held annually, usually in early November.

Nominations remain active indefinitely until formally accepted or declined by the TAHF Board of Directors. It is only necessary to nominate one time.

Authentication of service and/or accomplishment are the responsibility of the nominator and must accompany the nomination application.

Nominations can be submitted at any time.
